1. GENERAL INFORMATION

The Company was incorporated in the Cayman Islands on 18 December 2012 as an exempted company with limited liability under the Companies Law of the Cayman Islands and its shares have been listed on GEM of the Stock Exchange since 26 September 2013. The address of the Company's registered office is Clifton House, 75 Fort Street, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of the Company's head office and principal place of business in Hong Kong is Unit Nos. 1209-10, 12/F., Prosperity Millennia Plaza, No. 663 King's Road, North Point, Hong Kong.

The Group is principally engaged in the provision of financial trading software solutions, provision of other IT and internet financial platforms services, provision of referral services, money lending business and assets investments in Hong Kong. One of the subsidiaries of the Company holds the license in respect of type 6 (advising on corporate finance) regulated activity under the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) ("SFO").

The unaudited condensed consolidated results of the Group are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company, and all values are presented in thousands of units of Hong Kong dollars (HK\$'000), unless otherwise stated.

1. 一般資料

本公司於二零一二年十二月十八日根據開曼群島公司法在開曼群島註冊成立為獲豁免有限公司及其股份已於二零一三年九月二十六日起於聯交所GEM上市。本公司之註冊辦事處地址為 Clifton House, 75 Fort Street, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands。本公司的總辦事處及香港主要營業地點位於香港北角英皇道663號泓富產業千禧廣場12樓1209-10室。

本集團主要在香港從事提供金融交易軟件解決方案、提供其他資訊科技及互聯網金融平台服務、提供轉介服務、借貸業務及資產投資。本公司其中一間附屬公司持有關於香港法例第571章證券及期貨條例(「證券及期貨條例」)項下第6類(就機構融資提供意見)受規管活動的牌照。

本集團之未經審核簡明綜合業績以港元(「港元」)呈列，港元亦為本公司之功能貨幣，而除另有註明外，所有數值均以千港元(千港元)呈列。

2. BASIS OF PREPARATION

The unaudited condensed consolidated results of the Group for the nine months ended 30 September 2019 (“Results”) have been prepared in accordance with Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (hereinafter collectively referred to as “Hong Kong Financial Reporting Standards” (“HKFRSs”)), the accounting principles generally accepted in Hong Kong, the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622 of the Laws of Hong Kong) and the applicable disclosure provisions of the GEM Listing Rules.

The Results have been prepared on the historical cost basis, except for certain financial instruments that are measured at fair values at the end of each reporting period.

The accounting policies adopted in preparing the Results are consistent with those applied in the annual consolidated financial statements of the Group for the year ended 31 December 2018, with addition for the new HKFRSs and amendments to HKFRSs that have become effective for the Group’s financial year beginning on 1 January 2019.

The Group has not early applied the new HKFRSs and amendments to HKFRSs that have been issued but are not yet effective. The Group is in the process of making an assessment of their impact on the Group’s results of operations and financial position.

It should be noted that accounting estimates and assumptions are used in the preparation of the Results. Although these estimates are based on the management’s best knowledge and judgement to current events and actions, actual results may ultimately differ from those estimates.

2. 編製基準

本集團於截至二零一九年九月三十日止九個月之未經審核簡明綜合業績(「本業績」)乃根據由香港會計師公會頒佈之香港財務報告準則、香港會計準則及詮釋(以下統稱為「香港財務報告準則」)(「香港財務報告準則」)、香港公認會計原則、香港公司條例(香港法例第622章)之披露規定以及GEM上市規則之適用披露條文而編製。

本業績已根據歷史成本基準編製，惟於各報告期末按公平價值計量的若干金融工具除外。

編製本業績時採納之會計政策，與本集團截至二零一八年十二月三十一日止年度之年度綜合財務報表所採用的會計政策一致，並已加入於二零一九年一月一日開始之本集團財政年度生效之新訂香港財務報告準則及香港財務報告準則修訂本。

本集團並無提早採用已頒佈惟尚未生效之新訂香港財務報告準則及香港財務報告準則修訂本。本集團現正評估其對本集團之營運業績及財務狀況之影響。

謹請注意編製本業績時使用之會計估算及假設。雖然此等估算乃基於管理層對目前事件及行動之全悉及判斷，惟實際結果最終或會與該等估算有差別。

MANAGEMENT DISCUSSION AND ANALYSIS

During the nine months ended 30 September 2019 (“Period”), the Group was principally engaged in the provision of financial trading software solutions, provision of other IT and internet financial platforms services, provision of referral services, money lending business and assets investments in Hong Kong. During the Period, one of the subsidiaries of the Company held the license in respect of type 6 (advising on corporate finance) regulated activity under the SFO.

Business Review

Provision of financial trading software solutions

During the Period, the financial trading software solutions business division remained as the key source of income of the Group. The segment revenue from external customers contributed by the Group’s principal operating subsidiary, iAsia Online Systems Limited (“iAsia”), amounted to approximately HK\$47,719,000 (nine months ended 30 September 2018: approximately HK\$42,026,000), representing an increase of approximately HK\$5,693,000 or 13.5%.

Benefiting from the increasing trading volumes attributable to the Stock Connect, iAsia has maintained a stable growth in its revenue from the provision of multi-functional and comprehensive financial trading software solutions. During the Period, iAsia has continuously enhanced its financial trading software solutions to keep pace with the regulatory and new industry requirements. In addition, briefing and training were also provided to iAsia’s customers to ensure they kept up-to-date with the industry’s latest regulations and technology. Apart from the above, iAsia has also provided quality after-sales services to its customers, i.e. regular software licensing and maintenance services, so that iAsia would be able to keep abreast of the latest needs of its customers and maintain on-going relationships with its existing customers.

The Group will continue to keep up with the market trends and the industry requirements. The Group will also explore new business opportunities and expand its income stream from both existing and potential customers.

管理層討論及分析

於截至二零一九年九月三十日止九個月(「期內」)，本集團主要於香港從事提供金融交易軟件解決方案、提供其他資訊科技及互聯網金融平台服務、提供轉介服務、借貸業務及資產投資。於期內，本公司其中一間附屬公司持有關於證券及期貨條例項下第6類(就機構融資提供意見)受規管活動的牌照。

業務回顧

提供金融交易軟件解決方案

於期內，金融交易軟件解決方案業務分部仍為本集團的主要收入來源。本集團主要營運附屬公司亞洲網上系統有限公司(「亞網」)貢獻的來自外部客戶的分部收益約為47,719,000港元(截至二零一八年九月三十日止九個月：約42,026,000港元)，增加約5,693,000港元或13.5%。

受惠於滬深港通所帶來的交易量增長，亞網通過提供多功能及綜合金融交易軟件解決方案以維持收益的穩定增長。於期內，亞網不斷加強其金融交易軟件解決方案，以與監管及新行業規定保持同步。此外，亞網亦向其客戶提供簡報及培訓，確保彼等了解行業的最新法規及技術。除上述者外，亞網亦為其客戶提供優質的售後服務，即定期的軟件特許及保養服務以便亞網能夠及時了解客戶的最新需求並維持與現有客戶的持續關係。

本集團將繼續跟上市場趨勢及行業要求。本集團亦將開拓新的商機並擴大來自本集團現有及潛在客戶的收入流。

Provision of other IT and internet financial platforms services

During the Period, the provision of other IT and internet financial platforms services business division contributed revenue of approximately HK\$114,000 (nine months ended 30 September 2018: approximately HK\$486,000), representing a decrease of approximately HK\$372,000 or 76.5%.

In order to improve the sales performance of this business division, the Group will continue to diversify the provision of other IT services, such as providing system migration services to new customers. The Group will seize opportunities to diversify the client base of its provision of other IT and internet financial platforms services business in order to strengthen its competitiveness in the industry.

Money lending business

During the Period, revenue derived from the money lending business division amounted to approximately HK\$7,531,000 (nine months ended 30 September 2018: approximately HK\$6,135,000), representing an increase of approximately HK\$1,396,000 or 22.8%. The interest rate charged to customers during the Period ranged from 10% per annum to 15% per annum (nine months ended 30 September 2018: ranged from 8.5% per annum to 13% per annum).

The Group has advanced to an individual who is an independent third party of the Company (“Borrower”) a loan (“Loan”) in the principal amount of HK\$7,500,000, bearing interest ranging from 10% per annum to 11% per annum throughout its term and maturing on 2 July 2019. It came to the notice of the Company that a bankruptcy petition (“Petition”) had been filed with the Hong Kong courts against the Borrower. Taking into consideration the Petition and the facts that (i) the Borrower has defaulted in paying the interests on the Loan; (ii) the Loan is unsecured; and (iii) the Borrower is unable to provide satisfactory evidence to the Group in respect of his ability to repay the Loan and interests accrued thereon, collection of the Loan and interests would not be likely and accordingly, the Group recorded an impairment loss on loan and interest receivables of approximately HK\$7,703,000 for the Period. Notwithstanding that the Petition was withdrawn in July 2019, such impairment loss is still considered necessary given that the Borrower has not repaid the Loan on the maturity date. The Group is in the course of seeking legal advice on the above matter and will continue to pursue repayment of the Loan and the interests accrued thereon from the Borrower. The Company will keep the shareholders (“Shareholders”) of the Company informed of any further material developments in connection with the above matter by way of further announcement(s) as and when appropriate.

The Group reviews its credit control strategy from time to time so as to maintain a balance between the growth and risk management of its money lending business.

提供其他資訊科技及互聯網金融平台服務

於期內，提供其他資訊科技及互聯網金融平台服務業務分部錄得收益約114,000港元(截至二零一八年九月三十日止九個月：約486,000港元)，減少約372,000港元或76.5%。

為改善本業務分部的銷售表現，本集團將繼續多元化提供其他資訊科技服務，如向新客戶提供系統遷移服務。本集團將把握機會多元化提供其他資訊科技及互聯網金融平台服務業務的客戶基礎，以提升其行業競爭力。

借貸業務

於期內，借貸業務分部產生之收益約為7,531,000港元(截至二零一八年九月三十日止九個月：約6,135,000港元)，增加約1,396,000港元或22.8%。於期內向客戶收取之利率介乎每年10%至15%(截至二零一八年九月三十日止九個月：介乎每年8.5%至13%)。

本集團已向一名屬於本公司獨立第三方的個人(「借款人」)授出本金為7,500,000港元的貸款(「貸款」)，於貸款期內按年利率介乎10%至11%計息及於二零一九年七月二日到期。本公司得知，一項針對借款人的破產呈請(「呈請」)已提交香港法院。考慮到呈請及(i)借款人在支付貸款利息方面違約；(ii)貸款為無抵押；及(iii)借款人無法向本集團提供令人信納其有能力償還貸款及其應計利息的憑證之事實，收回貸款及應計利息的可能性不大，因此本集團於期內入賬應收貸款及利息減值虧損約7,703,000港元。儘管呈請已於二零一九年七月被撤回，但鑒於借款人於到期日並未償還貸款，有關減值虧損仍被認為屬必要。本集團正就上述事項尋求法律意見並將繼續追繳借款人償還貸款及其應計利息。本公司將適時通過進一步公告知會本公司股東(「股東」)有關上述事項的任何進一步重大進展。

本集團不時檢討其信貸控制策略，以保持其借貸業務的增長與風險管理之間的平衡。

Provision of referral services and provision of corporate finance advisory services

During the Period, no contract was made under the provision of referral services business division and no revenue was generated as a result (nine months ended 30 September 2018: Nil).

During the Period, the Group has been recruiting qualified staff to re-commence its provision of corporate finance advisory services business. No contract was made under the corporate finance advisory services business division and no revenue was generated for the Period as a result (nine months ended 30 September 2018: Nil).

Assets investments

The portfolio of the Group's assets investments business during the Period consisted of investments in securities that are held for trading. During the Period, no dividend income was received by the Group from its investments in listed securities that are held for trading (nine months ended 30 September 2018: Nil). During the Period, no addition or disposal of securities investments by the Group was recorded. Resulting from the volatile conditions of the Hong Kong stock market during the Period, a net fair value loss on financial assets at fair value through profit or loss of approximately HK\$1,683,000 (nine months ended 30 September 2018: Nil) was recognised from the Group's securities investments. The Directors expect that the stock market in Hong Kong will remain volatile which may affect the performance of the Group's securities investments. The Board believes that the performance of the securities investments of the Group will be dependent on the financial and operating performance of the investee companies and market sentiment, which are affected by factors, such as interest rate movements and performance of the macro economy. The Group will continue to adopt a conservative investment approach in its trading of listed securities in the Hong Kong stock market and closely monitor the performance of its securities investment portfolio.

提供轉介服務及提供企業財務諮詢服務

於期內，提供轉介服務業務分部並無簽訂合約，因此並無產生收益(截至二零一八年九月三十日止九個月：無)。

於期內，本集團一直在招聘合資格人員重新開始其從事提供企業財務諮詢服務業務。企業財務諮詢服務業務分部並無簽訂合約，因此期內並無產生收益(截至二零一八年九月三十日止九個月：無)。

資產投資

本集團於期內的資產投資業務組合包括持作買賣的證券投資。於期內，本集團並無收到持作買賣的上市證券投資的股息收入(截至二零一八年九月三十日止九個月：無)。於期內，本集團概無錄得有關證券投資的新增或出售。由於期內香港股市波動，已就本集團的證券投資確認按公平價值計入損益的金融資產的公平價值淨虧損約1,683,000港元(截至二零一八年九月三十日止九個月：無)。董事預期香港股市將持續波動，其或會影響本集團證券投資的表現。董事會相信，本集團證券投資的表現將取決於被投資公司的財務及營運表現以及市場氣氛，而該等方面受利率變動及宏觀經濟表現等因素影響。本集團將繼續採用謹慎的投資策略買賣香港股市的上市證券，並密切監控其證券投資組合的表現。

**Other investment: Equity investment (not held for trading)
— China Parenting Network Holdings Limited (“CPN”)**

As at 30 September 2019, the Group’s other investments that are not held for trading included 16,538,000 ordinary shares of CPN (“CPN Shares”), the issued shares of which are listed on the Main Board of the Stock Exchange (Stock Code: 1736), being approximately 1.61% of the total issued shares of CPN. CPN, together with its subsidiaries, operate an online platform focusing on the CBM (children, babies, and maternity) market in the People’s Republic of China and are mainly engaged in (i) provision of marketing and promotional services; and (ii) e-commerce business. The CPN Shares were measured at fair value at approximately HK\$3,887,000 as at 30 September 2019, based on their last closing price quoted on the Stock Exchange. During the Period, the fair value loss of CPN Shares transferred to the financial assets measured at fair value through other comprehensive income reserve of the Group was approximately HK\$744,000. During the Period, no dividend income was received from this investment (nine months ended 30 September 2018: approximately HK\$25,000).

Financial Review

Revenue, gross profit and gross profit margin

Revenue of the Group for the Period was approximately HK\$55,421,000 (nine months ended 30 September 2018: approximately HK\$49,196,000), representing an increase of approximately HK\$6,225,000 or 12.7% as compared with that of the corresponding period in 2018. The increase in revenue of the Group during the Period was mainly due to the increase in revenue generated from the financial trading software solutions business.

Gross profit of the Group for the Period was approximately HK\$40,734,000 (nine months ended 30 September 2018: approximately HK\$35,441,000), representing an increase of approximately HK\$5,293,000 or 14.9% as compared with that of the corresponding period in 2018, which is in line with the increase in revenue of the Group. Gross profit margin of the Group for the Period was approximately 73.5% (nine months ended 30 September 2018: approximately 72.0%), representing an increase of approximately 1.5% as compared with that of the corresponding period in 2018.

其他投資：股本投資(並非持作買賣)－中國育兒網絡控股有限公司(「中國育兒網絡」)

於二零一九年九月三十日，本集團並非持作買賣的其他投資包括中國育兒網絡(其已發行股份於聯交所主板上市，股份代號：1736)16,538,000股普通股(「中國育兒網絡股份」)，即中國育兒網絡全部已發行股份的約1.61%。中國育兒網絡及其附屬公司經營一個專注於中華人民共和國孕嬰童市場之網絡平台，主要從事(i)提供營銷及推廣服務；及(ii)電子商務業務。於二零一九年九月三十日，中國育兒網絡股份按公平價值計量約為3,887,000港元，乃基於其於聯交所所報最後收市價。於期內，轉撥至本集團按公平價值計入其他全面收入的金融資產之儲備的中國育兒網絡股份的公平價值虧損約為744,000港元。於期內，並無從該投資收取股息收入(截至二零一八年九月三十日止九個月：約25,000港元)。

財務回顧

收益、毛利及毛利率

本集團於期內的收益約為55,421,000港元(截至二零一八年九月三十日止九個月：約49,196,000港元)，較二零一八年同期的收益增加約6,225,000港元或12.7%。於期內本集團的收益增加主要是由於金融交易軟件解決方案業務所得收益增加。

本集團於期內的毛利約為40,734,000港元(截至二零一八年九月三十日止九個月：約35,441,000港元)，較二零一八年同期的毛利增加約5,293,000港元或14.9%，與本集團收益增加一致。本集團於期內的毛利率約為73.5%(截至二零一八年九月三十日止九個月：約72.0%)，較二零一八年同期的毛利率上升約1.5%。

Administrative expenses

The Group's administrative expenses for the Period amounted to approximately HK\$28,232,000 (nine months ended 30 September 2018: approximately HK\$23,737,000), representing an increase of approximately HK\$4,495,000 or 18.9% as compared with that of the corresponding period in 2018. The increase was primarily attributable to (i) the overall increase in operating expenses as a result of the continuous expansion of the Group's business; and (ii) additional spending on promotion and marketing.

Loss for the Period

The Group recorded a net loss after tax of approximately HK\$688,000 for the Period (nine months ended 30 September 2018: net profit after tax of approximately HK\$6,171,000). The unfavorable financial results of the Period was mainly attributable to the provision for impairment loss on loan and interest receivables of approximately HK\$7,703,000 recognised in the Period (nine months ended 30 September 2018: Nil).

Material Acquisition and Disposal

During the Period, the Group did not have any material acquisition or disposal transaction. As at the date of this report, the Group did not have any concrete plans for material investments or capital assets in the coming future. Nonetheless, if any potential investment opportunity arises and is identified, the Group will conduct a feasibility study and prepare implementation plans to consider whether it is beneficial to the Company and the Shareholders as a whole.

Capital Structure

As at 30 September 2019, the capital of the Company comprised ordinary shares only.

行政開支

本集團於期內的行政開支約為28,232,000港元(截至二零一八年九月三十日止九個月：約23,737,000港元)，較二零一八年同期的行政開支增加約4,495,000港元或18.9%。有關增加主要由於(i)本集團業務持續擴張導致經營開支整體上升；及(ii)推廣及營銷的額外支出。

期內虧損

本集團於期內錄得除稅後淨虧損約688,000港元(截至二零一八年九月三十日止九個月：除稅後淨溢利約6,171,000港元)。期內財務業績欠佳主要由於期內確認應收貸款及利息減值虧損撥備約7,703,000港元(截至二零一八年九月三十日止九個月：無)。

重大收購及出售

於期內，本集團並無任何重大收購或出售交易。於本報告日期，本集團並無關於未來之重大投資或資本資產的任何具體計劃。儘管如此，倘任何潛在投資機會來臨及得以識別時，本集團將進行可行性研究並編製實施計劃，以考慮有關機會是否符合本公司及股東的整體利益。

資本架構

於二零一九年九月三十日，本公司的資本僅包括普通股。

Share Option Scheme

The Company adopted a share option scheme ("Scheme") on 10 September 2013 so as to attract and retain the best available personnel and to provide additional incentive to the eligible participants under the Scheme. Pursuant to the Scheme, the Board is authorised, at its absolute discretion and subject to the terms of the Scheme, to grant options to subscribe for the shares of the Company (in such form then existing and subject to adjustment) to any employees (full-time or part-time), directors, consultants or advisor of the Group, or any substantial shareholders of the Group, or any distributors, contractors, suppliers, agents, customers, business partners or service providers of the Group. The Scheme shall be valid and effective for a period of ten years commencing on 10 September 2013 and expiring on the business day immediately preceding the 10th anniversary thereof, i.e. 8 September 2023, subject to early termination provisions contained in the Scheme.

The money lending business is another core business segment which has steadily generated income for the Group. The Group will continuously implement a prudent credit control policy and pay attention to credit risks in connection with corporate debts to balance the risk management and growth of the Group's money lending business.

The global economic outlook for 2019 faces multiple challenges which could exacerbate the financial market volatility in Hong Kong. To overcome the possible unfavorable economic environment in Hong Kong, the Group will continue to strive for excellence in its products and services, in order to maintain its international competitiveness and enhance its growth potential in the fintech industry. The Group believes diversification of its business segments can maintain a healthy financial profile and promote a sustainable growth of the Group. In the future, the Group will actively seize cooperation and acquisition opportunities with more business partners in various fields to expand its business scales and bring sustainable returns to the Shareholders.

借貸業務是另一項核心業務分部，為本集團產生穩定收入。本集團將繼續堅持實施審慎的信貸控制政策並關注公司債務的相關信貸風險以平衡本集團借貸業務的風險管理及發展。

二零一九年的全球經濟前景面臨多重挑戰，加劇香港金融市場的動盪。為克服香港可能出現的不利經濟環境，本集團將持續追求卓越的產品及服務，以保持國際競爭力，增強其於金融科技行業的增長潛力。本集團認為，業務分部多元化可維持穩健的財務狀況，促進本集團可持續增長。日後，本集團將積極把握與各領域的更多商業夥伴的合作及收購機會，以擴大其業務規模並為股東帶來可持續的回報。
