# CHAIRMAN'S STATEMENT

## 主席報告

Dear Shareholders,

On behalf of the board ("Board") of directors ("Directors") of Finsoft Financial Investment Holdings Limited ("Company"), I hereby present the annual results of the Company and its subsidiaries (collectively, "Group") for the year ended 31 December 2024 ("Year"). During the Year, the Group recorded revenue of approximately HK\$49,055,000, a decrease of approximately 6.3% when compared with that of approximately HK\$52,326,000 for the previous year. The basic and diluted loss per share for the Year were approximately HK2.53 cents (2023: approximately HK16.58 cents).

The business of the Group's principal operating subsidiary, iAsia Online Systems Limited ("iAsia"), contributed approximately 95.4% (2023: approximately 97.5%) of the Group's revenue for the Year. Affected by the local stagnant and conservative economic sentiment as well as fierce market competition, the revenue of iAsia decreased by approximately 8.3% to approximately HK\$46,780,000 (2023: approximately HK\$51,015,000) for the Year. iAsia will continue to serve its clients diligently and explore to secure new clients leveraging on its experience and expertise in the financial trading software solutions business.

The money lending business is another business segment of the Group. In light of the increasing number of new borrowing clients, revenue from the Group's money lending business was approximately HK\$2,275,000 for the Year (2023: approximately HK\$1,310,000), which increased by approximately 73.7%. Money lending business contributed to approximately 4.6% (2023: approximately 2.5%) of the total revenue of the Group for the Year. The Group will continue to strengthen its credit control strategy and loan management policies in order to mitigate its credit risks and improve its debt collection.

The Group's assets investments comprised securities investments during the Year. Resulting from the volatile Hong Kong financial market in the Year and the financial performance of the respective investee companies, the Group recorded a fair value loss on financial assets at fair value through profit or loss of approximately HK\$4,409,000 for the Year (2023: gain of approximately HK\$1,965,000).

致各位股東：

本人謹代表匯財金融投資控股有限公司（「本公司」）董事（「董事」）會（「董事會」）謹此呈列本公司及其附屬公司（統稱「本集團」）截至二零二四年十二月三十一日止年度（「本年度」／「年」）之年度業績。於年內，本集團錄得收益約49,055,000港元，較上一年的約52,326,000港元減少約6.3%。本年度的每股基本及攤薄虧損約為2.53港仙（二零二三年：約16.58港仙）。

本集團之主要營運附屬公司亞洲網上系統有限公司（「亞網」）的業務佔本集團本年度收益的約95.4%（二零二三年：約97.5%）。受當地經濟停滯不前及保守的經濟情緒以及市場競爭激烈的影響，亞網之收益下跌約8.3%至本年度的約46,780,000港元（二零二三年：約51,015,000港元）。亞網將繼續竭誠服務客戶，並探索藉助其金融交易軟件解決方案業務的經驗及專長贏得新客戶。

借貸業務為本集團的另一個業務分部。鑒於新增借貸客戶數目不斷增加，本集團於本年度借貸業務之收益為約2,275,000港元（二零二三年：約1,310,000港元），已增加約73.7%。借貸業務佔本集團本年度總收益的約4.6%（二零二三年：約2.5%）。本集團將繼續加強其信貸控制策略及貸款管理政策以降低信貸風險及改善債務催收。

於年內，本集團的資產投資包括證券投資。由於本年度香港金融市場波動及各被投資公司之財務表現，本集團於本年度錄得按公平價值計入損益的金融資產之公平價值虧損約4,409,000港元（二零二三年：收益約1,965,000港元）。



Under the heightened geopolitical uncertainties, followed by the sluggish property market in Hong Kong, the risk appetite for corporate investment, business expansion and personal consumption is expected to remain conservative in the near future.

Looking forward, the Group will continue to closely monitor the overall economic environment and emerging market trends. At the same time, the Group intends to implement stringent cost control measures and revamp operational efficiency of the existing businesses while exploring prudently for new business opportunities and fostering innovation.

Finally, on behalf of the Board, I would like to express my sincere gratitude to our shareholders, business partners and clients for their confidence and continuous support for the Group. I would also like to thank our staff for their dedications, commitment and determination to succeed.

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

During the Year, the Group was principally engaged in the provision of financial trading software solutions, provision of other IT and internet financial platforms services, money lending business and assets investments in Hong Kong.

### BUSINESS REVIEW

#### Provision of financial trading software solutions

During the Year, the financial trading software solutions business division remained as the key source of income of the Group. The segment revenue from external customers contributed by the Group's principal operating subsidiary, iAsia, amounted to approximately HK\$46,780,000 (2023: approximately HK\$51,015,000), representing a decrease of approximately 8.3%. During the Year, the results of iAsia has inevitably been affected by the local stagnant and conservative economic sentiment as well as fierce market competition.

During the Year, iAsia continued to strive for excellence in its products and services with its experienced fintech workforce. Its financial trading software solutions were optimized to cope with current market requirements.

As iAsia has built up reputation in the financial trading software solutions industry in Hong Kong and has a well-established customer base with sizeable banks and brokerage firms, the Group was able to generate stable sources of income during the Year. iAsia has also been devoted to strengthen its research and customer support capability with a view to developing new products according to market trends and industry requirements to maintain its competitiveness in the markets.

In order to foster cross-boundary innovation and leverage on the top-tier talents, the Group has established a research and development centre in Shenzhen in the first quarter of 2024.

#### Provision of other IT and internet financial platforms services

During the Year, no revenue was generated from the provision of other IT and internet financial platforms services business division (2023: Nil). In order to diversify the source of income, the Group will continue to seek for opportunities in providing other IT services, including but not limited to services related to artificial intelligence, blockchain technology, application development, etc.. The Group will seize opportunities to diversify the client base of its provision of other IT and internet financial platforms services business in order to strengthen its competitiveness in the industry.

於年內，本集團主要於香港從事提供金融交易軟件解決方案、提供其他資訊科技及互聯網金融平台服務、借貸業務及資產投資。

### 業務回顧

#### 提供金融交易軟件解決方案

於年內，金融交易軟件解決方案業務分部仍為本集團的主要收入來源。本集團主要營運附屬公司亞網貢獻的來自外部客戶的分部收益約為46,780,000 港元（二零二三年：約51,015,000 港元），減少約8.3%。於本年度，亞網的業績不可避免地受到當地經濟停滯不前及保守的經濟情緒以及市場競爭激烈的影響。

於年內，亞網與其經驗豐富的金融科技人才繼續追求卓越產品及服務，優化其金融交易軟件解決方案，以滿足當前市場要求。

由於亞網已於香港的金融交易軟件解決方案行業建立聲譽及擁有具規模的銀行及經紀行的成熟客戶群，本集團能夠於本年度產生穩定的收入來源。亞網亦致力於加強其研究及客戶支持能力，以根據市場趨勢及行業要求開發新產品，以維持其於市場的競爭力。

為培養跨境創新及藉助頂尖人才，本集團已於二零二四年第一季度在深圳設立研發中心。

#### 提供其他資訊科技及互聯網金融平台服務

於年內，並無錄得提供其他資訊科技及互聯網金融平台服務業務之分部收益（二零二三年：無）。為多樣化收入來源，本集團將繼續尋求提供其他資訊科技服務的機遇，包括但不限於人工智能、區塊鏈技術、應用開發等相關服務。本集團將抓住機會多樣化其提供其他資訊科技及互聯網金融平台服務業務的客戶群，以加強其行業競爭力。

### Money lending business

The Group provides its money lending business through its wholly-owned subsidiary, Finsoft Finance Limited (“FFL”), which holds a money lender’s licence under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong) (“MLO”). FFL offers loan financing services to both corporate and individual customers as its target clients in full compliance with the requirements under the MLO and the clients are mainly introduced by the Directors, existing clients and third party agents. During the Year, revenue derived from the money lending business division amounted to approximately HK\$2,275,000 (2023: approximately HK\$1,310,000), representing an increase of approximately 73.7%. The reversal of provision for impairment loss on loan and interest receivables for the Year amounted to approximately HK\$2,901,000 (2023: provision for impairment loss of approximately HK\$7,057,000). In assessing the expected credit loss allowance for loan and interest receivables, the Group considered (i) the loan receivables which have been past due as at 31 December 2024; (ii) the repayment history of loan and interest receivables of each borrower during the Year; and (iii) the probability of default rate due to the inability of the borrowers to make repayments to the Group when due.

As at 31 December 2024, the Group’s loan receivables balance (net of loss allowance) amounted to approximately HK\$35,677,000 (2023: approximately \$24,479,000), out of which approximately HK\$5,119,000 (2023: approximately HK\$5,137,000), representing approximately 14% (2023: approximately 21%) of the total loan receivables of the Group, was due from the largest borrower of the Group and an aggregate sum of approximately HK\$17,556,000 (2023: approximately HK\$14,640,000), representing approximately 49% (2023: approximately 60%) of the total loan receivables of the Group, was due from the five largest borrowers of the Group. The interest rate charged to the Group’s customers during the Year ranged from 8% per annum to 35.5% per annum (2023: 8% per annum to 21.6% per annum). As at 31 December 2024, the loan receivables had a fixed term ranging from 3 months to 25 months (2023: 3 months to 25 months). The Group held collaterals such as jewelry, properties and guarantees over its loan receivable balance of approximately HK\$11,167,000 (2023: approximately HK\$2,725,000). The Group had complied with the requirements set out in Chapter 19 and/or 20 of the GEM Listing Rules when it granted the loans to each of the borrowers, whose loan was still outstanding as at 31 December 2024, and the Group had not entered into any agreement, arrangement, understanding or undertaking (whether formal or informal and whether express or implied) with a connected person with respect to the grant of loans to the borrowers whose loans were still outstanding as at 31 December 2024. The Group’s money lending business will remain a sustainable business sector of the Group. The management of the Group monitors the loan and interest receivables balances on an on-going basis.

### 借貸業務

本集團透過其全資附屬公司匯財貸款有限公司（「匯財貸款」）提供借貸業務，該公司持有香港法例第163章放債人條例（「放債人條例」）項下之放債人牌照。匯財貸款全面遵守放債人條例項下的規定，向企業及個人客戶（兩者均為其目標客戶）提供貸款融資服務，客戶主要經董事、現有客戶及第三方代理引薦。於年內，借貸業務分部產生之收益約為2,275,000港元（二零二三年：約1,310,000港元），相當於增加約73.7%。於本年度應收貸款及利息的減值虧損撥備撥回為約2,901,000港元（二零二三年：減值虧損撥備約7,057,000港元）。於評估應收貸款及利息之預期信貸虧損撥備時，本集團已考慮(i)於二零二四年十二月三十一日已逾期之應收貸款；(ii)於年內各借款人的應收貸款及利息的歷史還款記錄；及(iii)因借款人未能於到期時向本集團還款之違約率概率。

於二零二四年十二月三十一日，本集團之應收貸款結餘（扣除虧損撥備）約35,677,000港元（二零二三年：約24,479,000港元），當中約5,119,000港元（二零二三年：約5,137,000港元），相當於本集團應收貸款總額的約14%（二零二三年：約21%），為應收本集團最大借款人之款項，而總額約17,556,000港元（二零二三年：約14,640,000港元），相當於本集團應收貸款總額的約49%（二零二三年：約60%）為應收本集團五大借款人之款項。於年內向本集團的客戶收取之利率介乎每年8%至35.5%（二零二三年：每年8%至21.6%）。於二零二四年十二月三十一日，應收貸款之固定期限介乎三個月至二十五個月（二零二三年：三個月至二十五個月）。本集團就其應收貸款結餘約11,167,000港元（二零二三年：約2,725,000港元）持有珠寶、物業等抵押及擔保。本集團在向各借款人（其貸款於二零二四年十二月三十一日仍未償還）授予貸款時，已遵守GEM上市規則第19章及／或第20章的規定，且本集團並無就向借款人（其貸款於二零二四年十二月三十一日仍未償還）授予貸款與關連人士達成任何協議、安排、諒解或承諾（無論為正式或非正式，亦無論為明示或暗示）。本集團的借貸業務仍將為本集團之可持續發展業務分部。本集團管理層持續監察應收貸款及利息結餘。

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

As at 31 December 2024, there were 34 borrowers (consisting of 31 individual borrowers and 3 corporate borrowers) whose loans remained outstanding. The individual borrowers comprise mainly management officer and merchants, while the corporate borrowers comprise one private company and a subsidiary of a listed company in Hong Kong. All of these individual borrowers had solely unsecured loans outstanding, except that one borrower had both unsecured loans and secured loan outstanding; three borrowers had secured loans outstanding; and two borrowers had unsecured but guaranteed loans outstanding. Two corporate borrowers had unsecured but guaranteed loans outstanding; and one corporate borrower had a unsecured loan outstanding.

As at 31 December 2024, the loan receivables (net of loss allowance) amounted to approximately HK\$35,677,000, the ageing analysis of which based on the remaining contractual maturity date and net of loss allowance is set out below:

於二零二四年十二月三十一日，有 34 名借款人（包括 31 名個人借款人及 3 名公司借款人）的貸款仍未償還。個人借款人主要包括管理層成員及商戶，而公司借款人包括一間私人公司及一間香港上市公司附屬公司。所有個人借款人均僅有未償還的無抵押貸款，除了一名借款人同時擁有未償還的無抵押貸款及有抵押貸款；三名借款人有未償還的有抵押貸款；及兩名借款人有未償還的無抵押但有擔保貸款。兩名公司借款人有未償還的無抵押但有擔保貸款；及一名公司借款人有一筆未償還的無抵押貸款。

於二零二四年十二月三十一日，應收貸款（扣除虧損撥備）約為 35,677,000 港元，其賬齡分析（基於餘下合約到期日及扣除虧損撥備）載列如下：

### Internal control procedures

In order to minimise the credit risks and default risks associated with the money lending business, FFL has its internal control and work procedure manual in provision of the loan financing services. When clients approach FFL for a request on loan financing, client identification procedures will take place with officers of FFL enquiring the potential clients' information. Individual clients are required to provide documents including but not limited to his/her Hong Kong identity card or passport and residential address proof and corporate clients are required to provide documents including but not limited to the certificate of incorporation, registers of members and directors, the articles of association, the certificate of incumbency and/or certificate of good standing (where applicable). An application form will be filled in and submitted to FFL.

Generally, credit worthiness assessments will take place for potential individual and corporate clients by (1) doing financial assessments such as obtaining bank and security statements, income proof, property proof, its audited financial statements and/or the latest management account (if any); and (2) conducting different searches such as bankruptcy or winding up search, land search and credit search.

### 內部監控程序

為將與借貸業務相關的信貸風險及違約風險降至最低，匯財貸款訂有提供貸款融資服務的內部監控及工作程序手冊。倘客戶向匯財貸款提出貸款融資請求，匯財貸款將啟動客戶身份識別程序，工作人員將查詢潛在客戶的資料。個人客戶須提供（包括但不限於）彼之香港身份證或護照及住址證明等文件，而企業客戶則須提供（包括但不限於）註冊證書、股東及董事名冊、組織章程細則、董事在職證明及／或公司存續證明（如適用），填妥申請表格並遞交至匯財貸款。

一般而言，對潛在個人及企業客戶的信譽評估將透過以下方式進行：(1) 進行財務評估，如獲取銀行及證券報表、收入證明、財產證明、其經審核財務報告及／或最新管理賬目（如有）；及(2) 進行多種調查，如破產或清盤調查、土地查冊及信用調查。

FFL has in place all measures to duly observe relevant laws, rules and regulations including but not limited to those in connection with sanctions or terrorist financing risk of potential clients and/or its businesses, such as the nature and details of the business/occupation/employment of the potential clients (if applicable); the nationality of potential clients; the expected source and origin of the funds to be used; and the initial and ongoing source(s) of wealth or income (if applicable). FFL performs monitoring on clients as to their credit risk and reviews the extent required for clients' due diligence and the ageing of loan and interest receivables balances on an ongoing basis.

In determining the loan terms (including but not limited to the interest rate and the duration of the loan), FFL refers to the prevailing market practices in order to lower FFL's exposure and will take into account the requirement of security, personal or corporate guarantee, the background of the potential clients (with reference to the documents provided and their reputation) and the results of credit risk assessment on those potential clients. The terms of the loans to be granted and the necessary loan documentations would be subject to the approval process.

For loans in the amount of less than HK\$5 million, any one member of the credit committee of the Company ("Credit Committee") may approve the grant of such loans. For loans in the amount of more than HK\$5 million but less than HK\$10 million, the unanimous consent of the members of the Credit Committee is required for approving the grant of such loans. For loans in the amount of more than HK\$10 million, a majority vote from the Board is required for approving the grant of such loans.

Notwithstanding the monetary threshold stated above, FFL will also review whether any proposed transactions may constitute notifiable transactions or connected transactions to ensure the proposed transactions will be conducted in compliance with the applicable requirements under the GEM Listing Rules and the applicable rules and regulations.

FFL will monitor continuously the loan and interest payment according to the terms of the loan agreements and follow up closely with its clients as to the deadlines in payment of the loan or interest. FFL's officers remind borrowers regularly for repayment of loan instalments and the interests accrued thereon in accordance with the repayment schedule agreed for such loans, and with those reminders, the officers will also check as to whether the borrowers agree with the balance of the loans. FFL has standard procedure in dealing with default in payment. The officers of FFL will report to the Credit Committee on the loans' respective repayment status on a monthly basis and any cases of default in repayment will be reported to the Credit Committee immediately.

匯財貸款已採取一切措施以遵守相關法例、法規及規定，包括但不限於與潛在客戶及／或其業務制裁或恐怖主義融資風險相關者，如潛在客戶之業務／職業／僱傭之性質及詳情（如適用）；潛在客戶之國籍；所用資金之預期來源及出處；以及最初及持續的財富或收入來源（如適用）。匯財貸款監控客戶的信貸風險，並持續檢討客戶的盡職調查程度以及應收貸款及利息結餘的賬齡。

於釐定貸款之條款（包括但不限於貸款利率及貸款期限）時，匯財貸款會參考現行市場慣例，以降低匯財貸款的風險，並將安全要求、個人或企業擔保、潛在客戶背景（參考所提供文件及彼等之信譽）以及對該等潛在客戶進行信貸風險評估之結果考慮在內。將授出貸款之條款及必要貸款文件將視乎審批程序而定。

對於金額少於 5,000,000 港元之貸款，本公司信貸委員會（「信貸委員會」）的任何一名成員可批准授出有關貸款。對於金額多於 5,000,000 港元但少於 10,000,000 港元之貸款，須獲得信貸委員會成員的一致同意以批准授出有關貸款。對於金額多於 10,000,000 港元之貸款，須獲得董事會之大多數票以批准授出有關貸款。

儘管有上述金額門檻，匯財貸款亦將審閱是否有任何建議交易可能構成須予披露交易或關連交易，以確保建議交易將按 GEM 上市規則項下之適用規定以及適用法規及規則進行。

匯財貸款將根據貸款協議之條款持續監控貸款及利息支付，並與其客戶密切跟進貸款或利息的支付期限。匯財貸款的高級職員根據就有關貸款協定的還款時間表定期提醒借款人償還貸款分期付款及應計利息，而在作出該等提醒後，高級職員亦將核查借款人對有關貸款餘額是否有異議。匯財貸款已制定處理拖欠付款的標準程序。匯財貸款的高級職員將每月向信貸委員會匯報貸款的相關還款情況，而拖欠還款的任何情況將即時向信貸委員會匯報。

A debts collection policy is also in place within the Group to collect the borrowers' outstanding debts. In cases of default and/or delinquent loans, the recovery procedure of the debts collection policy will commence and the officers of FFL will (i) send reminder letters or e-mails or Whatsapp to the borrowers for repayment; (ii) arrange for negotiations with the borrowers for the repayments or settlement of loans and accrued interests; and (iii) request settlement of the outstanding amount owed to the Group through telephone calls, from time to time. The Group may also engage lawyers in advising on the loan and its recovery and enforcement action. These lawyers may be engaged as well to (i) issue demand letters to the borrowers in default of their repayment, demanding for repayment of the outstanding amount owed to FFL; and (ii) advise and assist in the potential legal actions required for the enforcement of the loans with default in repayment. Subject to applicable laws and regulations including but not limited to the MLO, third-party debt collection agencies may be engaged to recover the overdue amounts owed.

### **Provision for impairment loss on loan and interest receivables**

The assessment of the Group's provision for impairment loss on loan and interest receivables for the Year was performed under the expected credit loss ("ECL") model in accordance with Hong Kong Financial Reporting Standard ("HKFRS") 9 Financial Instruments. The key measuring parameters and inputs of the ECL approach include probability of default ("PD"), loss given default ("LGD") and exposure at default ("EAD"), which are based on the assessed creditworthiness of the borrowers.

In determining the credit risk of the borrowers, the Company considered the following factors: (a) if it is an individual borrower or a corporate borrower; (b) the industry where the corporate borrower operates; (c) the internal credit assessment of the borrower; and (d) the historical repayment records of, and the working relationship with, the borrower.

In determining whether there have been significant increases in credit risk, the following key criteria are taken into account:

- (a) an actual or expected significant deterioration in the borrower's external (if available) or internal credit rating;
- (b) significant deterioration in external market indicators of credit risk for the corporate borrower;
- (c) existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the borrower's ability to meet its debt obligations;
- (d) an actual or expected significant deterioration in the operating results of the corporate borrower;
- (e) significant increases in credit risk on other financial instruments of the same corporate borrower;

本集團亦制定債務收回政策以收回借款人的尚未償還債務。倘出現拖欠及／或逾期貸款，將啟動債務回收政策的收回程序，匯財貸款的高級職員將 (i) 向借款人發送要求還款的催繳函或催繳電郵或 Whatsapp; (ii) 就償還或結算貸款及應計利息安排與借款人進行磋商；及 (iii) 不時透過電話催繳要求清償結欠本集團的尚未償還金額。本集團亦可委聘律師，以就貸款以及其收回及強制執行行動提供意見。亦可委聘該等律師以 (i) 向拖欠還款的借款人發出催繳函，要求償還結欠匯財貸款的未償還金額；及 (ii) 提供意見並協助強制執行拖欠還款之貸款須採取的潛在法律行動。在適用法律法規（包括但不限於放債人條例）的規限下，可委聘第三方催收公司收回結欠的逾期款項。

### **應收貸款及利息的減值虧損撥備**

本集團根據香港財務報告準則（「香港財務報告準則」）第9號金融工具項下之預期信貸虧損（「預期信貸虧損」）模式對於年內應收貸款及利息的減值虧損撥備進行評估。預期信貸虧損法之主要計量參數及輸入數據包括基於借款人經評估的信貨質素的違約概率（「違約概率」）、違約虧損率（「違約虧損率」）及違約風險（「違約風險」）。

本公司於釐定借款人的信貸風險時已考慮以下因素：(a) 借款人是否為個人或公司；(b) 公司借款人業務營運所處的行業；(c) 借款人的內部信貸評估；及 (d) 借款人的過往還款記錄及與其之工作關係。

於釐定信貸風險是否顯著增加時，已考慮下列主要標準：

- (a) 借款人的外部（如可獲取）或內部信用評級的實際或預期顯著惡化；
- (b) 公司借款人的外部市場信貸風險指標的顯著惡化；
- (c) 預期將導致借款人履行其債務責任的能力顯著下降的業務、財務或經濟狀況的現有或預期不利變動；
- (d) 公司借入人經營業績的實際或預期顯著惡化；
- (e) 同一公司借款人的其他金融工具的信貸風險顯著上升；

- (f) an actual or expected significant adverse change in the regulatory, economic or technological environment of the borrower that results in a significant decrease in the borrower's ability to meet its debt obligations;
- (g) status of the loan and interest receivables as at the reporting date, including any breach of contract such as a default or past due event as at the reporting date; and
- (h) whether it is probable that the borrower will enter bankruptcy or other financial reorganisation.

A borrower will be regarded as credit-impaired if he is in default of the loan principal, or has entered bankruptcy or other financial reorganisation, or has severely delayed payments of the loan principal or interests.

The Group categorises the credit quality of its loan and interest receivables according to 3 different stages under the ECL model:

Stage 1: financial assets without significant increase in credit risk since initial recognition where loss allowance is calculated based on 12-month ECL;

Stage 2: financial assets with significant increase in credit risk since initial recognition where loss allowance is calculated based on lifetime ECL; and

Stage 3: credit impaired assets where loss allowance is calculated based on lifetime ECL.

In general, loan and interest receivables that are not defaulted and have no sign of any significant increase in credit risk, including loans which were still outstanding as at 31 December 2024 but the principal has been repaid partially and the borrowers and the Group have entered into supplemental loan agreements, are categorised as Stage 1 assets and the Group adopted the PD published by the credit rating agencies and credit reporting agencies based on the background of the borrowers and credit analysis performed. Regarding the LGD, relevant market value of the collateral has been considered when determining the LGD.

For borrowers that are identified to have significant increases in credit risk, including borrowers who have entered into settlement agreements with the Group due to default in and/or late repayment of their respective loans, their loan and interest receivables are categorised as Stage 2 assets and the Group adopted the PD by referring to the high risk categories for the corresponding type of the borrower (i.e. individual borrower or corporate borrower).

For borrowers that are identified to be credit-impaired, including borrowers who are in default of the loan principal, or have entered bankruptcy or other financial reorganisation, or have severely delayed payments of the loan principal or interests, their loan and interest receivables are categorised as Stage 3 assets and the Group applied the PD of the lowest credit categories.

- (f) 借款人所處的監管、經濟或技術環境實際或預期發生顯著不利變化，而有關變化導致借款人償還債務能力大幅下降；

- (g) 於報告日期應收貸款及利息之狀況，包括於報告日期的任何違約事件，如拖欠或逾期；及

- (h) 借款人是否將有可能破產或進行其他財務重組。

倘借款人拖欠貸款本金、破產或進行其他財務重組或嚴重拖欠貸款本金或利息付款，則其將被視為發生信貸減值。

根據預期信貸虧損模式，本集團根據三個不同階段對應收貸款及利息的信貸質素進行分類：

階段 1：自初始確認後信貸風險並無顯著增加的金融資產，其虧損撥備根據 12 個月預期信貸虧損計算；

階段 2：自初始確認後信貸風險顯著增加的金融資產，其虧損撥備根據全期預期信貸虧損計算；及

階段 3：信貸減值資產，其虧損撥備根據全期預期信貸虧損計算。

一般而言，未違約且並無跡象表明信貸風險大幅增加的應收貸款及利息（包括於二零二四年十二月三十一日仍未償還的貸款，而本金已部分償還以及借款人與本集團已訂立補充貸款協議）分類為階段 1 的資產，本集團採納信貸評級機構及信貸報告機構根據借款人的背景及進行的信貸分析發佈的違約概率。對於違約虧損率，釐定違約虧損率時已考慮抵押品的相關市值。

對於識別到信貸風險大幅上升的借款人（包括因拖欠及／或逾期償還其各自貸款而與本集團訂立結算協議的借款人），彼等的應收貸款及利息分類為階段 2 的資產，本集團參照相應類別借款人（即個別借款人或公司借款人）的高風險類別採納違約概率。

就確認為發生信貸減值的借款人（包括拖欠貸款本金或已進入破產或其他財務重組或已個別延遲支付貸款本金或利息的借款人）而言，彼等的應收貸款及利息分類為階段 3 的資產，本集團應用最低信貸分類的違約概率。

The assumptions adopted in the ECL assessment are as follows:

- (a) the market trends and conditions where the borrowers operate will not deviate significantly from economic forecasts in general; and
- (b) the probabilities of defaults as extracted from TransUnion, Moody's and market statistics are assumed to be unbiased.

As at 31 December 2024, the Group had a total of 34 borrowers (31 December 2023: 31) with total outstanding loan principal and interest receivables in the sum of approximately HK\$71,817,000 (31 December 2023: approximately HK\$91,156,000). The Group has identified its 34 borrowers as at 31 December 2024 into the aforesaid three stages under the ECL approach as follows:

- (a) Stage 1: 10 borrowers (31 December 2023: 1) were identified to be in Stage 1;
- (b) Stage 2: 12 borrowers (31 December 2023: 13) were identified to be in Stage 2;
- (c) Stage 3: 12 borrowers (31 December 2023: 17) were identified to be in Stage 3.

預期信貸虧損評估所採用的假設如下：

- (a) 借款人經營所在地之市場趨勢及狀況與整體經濟預測並無重大偏差；及
- (b) 摘取環聯、穆迪及市場分析數據的違約概率假設並無偏差。

於二零二四年十二月三十一日，本集團共有 34 名（二零二三年十二月三十一日：31 名）借款人，未償還貸款本金總額及應收利息合計約 71,817,000 港元（二零二三年十二月三十一日：約 91,156,000 港元）。於二零二四年十二月三十一日，本集團已將其 34 名借款人確定為上述預期信貸虧損方法項下的三個階段，具體如下：

- (a) 階段 1：10 名（二零二三年十二月三十一日：1 名）借款人被確定處於階段 1；
- (b) 階段 2：12 名（二零二三年十二月三十一日：13 名）借款人被確定處於階段 2；
- (c) 階段 3：12 名（二零二三年十二月三十一日：17 名）借款人被確定處於階段 3。



The Group has recorded a reversal of provision for impairment loss on loan and interest receivables of approximately HK\$2,901,000 during the Year (2023: provision for impairment loss of approximately HK\$7,057,000). The reversal of provision for impairment loss on loan and interest receivables for the Year is mainly attributable to the settlement of approximately HK\$2,600,000 from two individual borrowers which were identified in Stage 3 under the ECL model of the Group in prior year.

The senior staff of the Group have been sending reminder letters, e-mails and Whatsapp messages to such borrower requesting for repayment, and have arranged for negotiations with such borrower on settlement of the outstanding loan and accrued interests. The Group plans to engage lawyers to advice on the loan and its recovery and enforcement action.

Save as disclosed above, there was no material change in the credit status and credentials of the loan and interest receivables of the Group as at 31 December 2024 using the Group's ECL model.

There was no significant change to the basis, assumptions and inputs adopted in the ECL assessment for the Year from those adopted in the previous year.

The Directors believe that the credit assessment on the loans and interest receivables based on the Company's money lending policy will provide a fair and reasonable estimate of the impairment losses.

The Company has instructed its legal advisers to issue demand letters or emails to the borrowers who have overdue loans demanding immediate repayment of the outstanding loan principal and interests. Legal advice has been sought for potential further legal actions including but not limited to issuing statutory demands. The Company will carry on ongoing periodic review and negotiations with borrowers for repayment or settlement of their overdue balances to mitigate the financial impact to the Group and ensure adherence to its money lending policy.

於年內，本集團錄得應收貸款及利息的減值虧損撥備撥回約 2,901,000 港元（二零二三年：減值虧損撥備約 7,057,000 港元）。本年度應收貸款及利息之減值虧損撥備撥回乃主要是由於兩名個人借款人結算款項約 2,600,000 港元，有關款項於去年確定處於本集團預期信貸虧損模式項下的階段 3。

本集團高級職員已向借款人發送要求還款的催繳函、催繳電郵及 Whatsapp 信息，並已就償還未償還貸款及應計利息安排與借款人進行磋商。本集團計劃聘請律師就貸款及其追討及強制行動向本集團提供建議。

除上文所披露者外，本集團於二零二四年十二月三十一日使用本集團預期信貸虧損模型，其應收貸款及利息的信貸狀況及資信概無發生重大變化。

與過往年度相比，本年度預期信貸虧損評估所採用的基準、假設及輸入數據並無重大變化。

董事認為，根據本公司的借貸政策對應收貸款及利息的信用評估將提供一個公平及合理的減值損失估計。

本公司已指示法律顧問向貸款逾期的借款人發出催款函或電子郵件，要求彼等立即償還未償還貸款本金及利息。本公司已就可能進一步採取的法律行動尋求法律意見，包括但不限於發出法定償債書。本公司將就償還或結算逾期結餘與借款人持續進行定期檢討及磋商以減輕對本集團的財務影響並確保遵守其借貸政策。

### Notes:

- (a) GBA and its subsidiaries (collectively referred to as “GBA Group”) are principally engaged in the property business, finance business, automobile business and catering business. As disclosed in the interim report of GBA for the six months ended 30 June 2024, (i) the unaudited revenue and loss of GBA for the six months ended 30 June 2024 were approximately HK\$29.4 million and HK\$26.7 million respectively; and (ii) the GBA Group would continue to expand the business based on market demand and availability of funds.
- (b) Asia Energy and its subsidiaries (collectively referred to as “Asia Energy Group”) are principally engaged in telecommunications related business and shipping and logistics. As disclosed in the interim report of Asia Energy for the six months ended 30 June 2024, (i) the unaudited revenue and loss of Asia Energy for the six months ended 30 June 2024 were approximately HK\$22.9 million and HK\$22.2 million respectively; (ii) the Asia Energy Group would be careful in promoting its telecommunications related business development and actively explore new customer and (iii) the Asia Energy Group would be in close watch of the market conditions of shipping and logistics, including but not limited to the price of vessels and its own financial position, so that vessel acquisition will only materialize in the best interest of the Asia Energy Group should an acquisition opportunity arise.
- (c) PT International and its subsidiaries (collectively referred to as “PT International Group”) are principally engaged in the businesses of investment holding, trading of commodities, recycling and trading of metals, chemical storage business, provision of management services, financial institute business and loan financing services. As disclosed in the interim report of PT International for the six months ended 30 September 2024, (i) the unaudited revenue and loss of PT International for the six months ended 30 September 2024 were approximately HK\$76.0 million and HK\$48.0 million respectively; and (ii) the PT International Group are looking for new methods and technologies to improve productivity, increase petrochemical sales and provide better and more efficient services for oil storage business customers. The PT International Group would strive to increase revenue contribution and will continue to explore on further expansion opportunities for the business.
- (d) Minerva and its subsidiaries (collectively referred to as “Minerva Group”) are principally engaged in financial services, money lending and assets investment. As disclosed in the interim report of Minerva for the six months ended 30 June 2024, (i) the unaudited revenue and profit of Minerva for the six months ended 30 June 2024 were approximately HK\$36.5 million and HK\$14.0 million respectively; (ii) the Minerva Group would continue to expand into corporate and individual loans and carefully evaluate its risk management strategies and ensure a proper balance between risks and returns and over the long run. The Minerva Group would continue to cautiously monitor the general business environment and market conditions to mitigate the potential impact to our operations and investments while also seeking potential investment and business opportunities for further development of its various business segments, expanding the business scope and creating a new dynamic for revenue growth.

- (e) SDHG and its subsidiaries (collectively referred to as “SDHG Group”) are principally engaged in operations of industrial investment-related business, trading of listed securities and listed bonds primarily for interest income, dividend income and capital appreciation, direct investment business including investments in debts instruments, unlisted bonds, notes, unlisted equity investments and investment funds and provision of money lending services, securities brokerage services, asset management services, financial leasing, advisory services and asset trading platform. As disclosed in the interim report of SDHG for the six months ended 30 June 2024, (i) the unaudited revenue and profit of SDHG for the six months ended 30 June 2024 were approximately HK\$3,069.2 million and HK\$85.0 million respectively; (ii) the SDHG Group would continue to expand into corporate and individual loans and carefully evaluate its risk management strategies and ensure a proper balance between risks and returns and over the long run. The SDHG Group would continue to cautiously monitor the general business environment and market conditions to mitigate the potential impact to our operations and investments while also seeking potential investment and business opportunities for further development of its various business segments, expanding the business scope and creating a new dynamic for revenue growth.
- (f) China Nuclear and its subsidiaries (collectively referred to as “China Nuclear Group”) are principally engaged in the provision of engineering, procurement and construction and consultancy and general construction services, power generation and financing service. As disclosed in the interim report of China Nuclear for the six months ended 30 June 2024, (i) the unaudited revenue and profit of China Nuclear for the six months ended 30 June 2024 were approximately HK\$821.1 million and HK\$77.3 million respectively; and (ii) the China Nuclear Group will invest in energy storage projects to promote business diversification and industry segmentation. The China Nuclear Group would continue to strengthen its project management to develop more high-quality projects and ensure that the projects undertaken by the Group will be connected to the grid as scheduled. The China Nuclear Group would continue to optimize the construction and implementation of the project management system, enhance the inspection, supervision and assessment of the projects, so as to raise the standard of project management and strive to become an advanced international integrated energy service provider as soon as possible, and contribute more to the development of the national clean energy industry.
- (g) Crown and its subsidiaries (collectively referred to as “Crown Group”) are principally engaged in (i) property investment; (ii) property development; (iii) hotel operations; and (iv) provision of comprehensive healthcare planning and management services in the People’s Republic of China (“PRC”). As disclosed in the interim report of Crown for the six months ended 30 September 2024, (i) the unaudited revenue and loss of Crown for the six months ended 30 September 2024 were approximately HK\$17.5 million and HK\$2.0 million respectively; and (ii) the current principal businesses of the Crown Group include property investment, property development, hotel operations and provision of comprehensive healthcare planning, trading and developing of premium white spirit and management services in the PRC. The Crown Group is under the development to cooperate with property owners to modify property projects into high-end healthcare projects and combined with the capital operation of insurance companies and financial institutions to jointly operate healthcare projects. During the Year, the Group disposed of its investment in the shares of Crown and recorded a net realised loss of approximately HK\$328,000.

- (f) 中國核能及其附屬公司（統稱為「中國核能集團」）主要從事提供工程、採購及建設及諮詢及整體建設服務、發電及融資服務。誠如中國核能於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 中國核能截至二零二四年六月三十日止六個月的未經審核收益及溢利分別約為 821,100,000 港元及 77,300,000 港元；及 (ii) 中國核能集團將投資儲能項目推動業務多元化、行業細分化。中國核能集團將繼續加強項目管理，做出更多精品工程，確保承接的項目如期併網發電。中國核能集團將一如既往地抓好項目管理制度的建設、宣貫落實工作，加大對項目的巡察、監督、考核，切實提高項目管理的水平，爭取盡早跨入國際先進的綜合能源服務商行列，為國家清潔能源事業發展貢獻更多力量。
- (g) 皇冠及其附屬公司（統稱為「皇冠集團」）主要於中華人民共和國（「中國」）從事 (i) 物業投資；(ii) 物業開發；(iii) 酒店營運；及 (iv) 提供大健康策劃管理服務。誠如皇冠於截至二零二四年九月三十日止六個月的中期報告所披露，(i) 皇冠截至二零二四年九月三十日止六個月的未經審核收益及虧損分別約為 17,500,000 港元及 2,000,000 港元；及 (ii) 皇冠集團目前的主營業務包括於中國的物業投資、物業發展、酒店營運及提供大健康策劃、優質白酒貿易及發展及管理服務。皇冠集團正在發展與業主方合作，將物業項目改造為高端康養項目，再結合與保險公司及金融機構之資本運作，共同經營康養項目。年內，本集團出售其於皇冠股份的投資，並錄得已變現淨虧損約 328,000 港元。

- (h) VC and its subsidiaries (collectively referred to as “VC Group”) are principally engaged in the provision of financial services, proprietary trading and sale and distribution of healthcare products. As disclosed in the interim report of VC for the six months ended 30 June 2024, (i) the unaudited revenue and loss of VC for the six months ended 30 June 2024 were approximately HK\$36 million and HK\$65.9 million respectively; (ii) the VC Group intends to remain an all-rounded service provider while it will allocate additional resources to enhance the development of its asset management and insurance brokerage businesses; (iii) the VC Group adopted a prudent approach in its financing business and will optimize resource allocation to ensure efficient use of resources and will actively explore new business and investment opportunities across various sectors, aiming to drive steady growth while adapting to the evolving market environment; and (iv) the VC Group intends to expand its client base and improve the quality of its asset management services by leveraging on its brands, reputations and management expertise, and boosting its core industry strengths.
- (i) Jiande and its subsidiaries (collectively referred to as “Jiande Group”) are principally engaged in property development in the PRC. As disclosed in the interim report of Jiande for the six months ended 30 June 2024, (i) the unaudited revenue and loss of Jiande for the six months ended 30 June 2024 were approximately RMB63.9 million and RMB3.8 million respectively; and (ii) the Jiande Group would continue to uphold its prudent management approach to maintain a balance between growth, efficiency and risk. The Jiande Group has committed to developing quality properties accompanied with a living community to customers, particularly in those cities in the PRC where the rigid demand for housing remains solid due to the continuous urbanization process. The Jiande Group would also aim at being customer-centred and innovating product functions to realise customers’ pursuit for better lives. During the Year, the Group disposed of its investment in the 8,000,000 shares of Jiande and recorded a net realised loss of approximately HK\$119,000.
- (j) Huaneng Power and its subsidiaries (collectively referred to as “Huaneng Power Group”) are engaged in developing, constructing, operating and managing power plants throughout China. As disclosed in the interim report of Huaneng Power for the six months ended 30 June 2024, (i) the unaudited revenue and loss of Huaneng Power for the six months ended 30 June 2024 were approximately RMB118,805.9 million and RMB9,430.5 million respectively; and (ii) the Huaneng Power Group will strengthen the research on climate changes and power supply and demand in each region, make the most of the summer and winter seasons when the demand is high and sufficient power supply is crucial and optimize the timing and structure of power generation and endeavors to make the best of the high-priced hours to generate more power and hence improve efficiency. The Huaneng Power Group would closely track changes in the coal market, strive to improve the performance rate of long-term contracts, give full play to the role of a stabilizer of those long-term contracts. The Company will capture international coal market momentums to import coal, continue to optimize the supply structure, enhance the ability of power generation units to ensure power supply in peak seasons, strengthen inventory management, and make the best use of the strategy of stocking up in off seasons. The Huaneng Power Group would optimize the debt maturity structure, make efforts to control financing costs, guard against capital risks, and achieve cost reduction and efficiency.
- (k) SMIC and its subsidiaries (collectively referred to as “SMIC Group”) are principally engaged in the computer-aided design, sales and marketing, technical research and development, manufacturing, trading of integrated circuits and other semiconductor services, as well as designing and manufacturing semiconductor masks, respectively. As disclosed in the interim report of SMIC for the six months ended 30 June 2024, (i) the unaudited revenue and profit of SMIC for the six months ended 30 June 2024 were approximately US\$3,651.5 million and US\$235.8 million respectively; and (ii) the SMIC Group had made steadily progress in capacity layout, showed notable initial results in key projects, accelerated establishment of partnerships ecosystem and comprehensively improved management efficiency and capability.
- (h) 滙盈及其附屬公司（統稱為「滙盈集團」）主要從事提供金融服務、自營買賣以及銷售及分銷醫療保健產品業務。誠如滙盈於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 滙盈截至二零二四年六月三十日止六個月的未經審核收益及虧損分別約為 36,000,000 港元及 65,900,000 港元；(ii) 滙盈集團將計劃繼續成為全方位服務供應商，同時其將投入更多資源加強資產管理及保險經紀業務的發展；(iii) 滙盈集團在融資業務方面採取審慎態度，並將優化資源分配，確保有效運用資源，並積極在各行各業發掘新的業務及投資機遇，務求在適應瞬息萬變的市場環境之同時，推動業務穩步增長；及 (iv) 滙盈集團將計劃利用其品牌、聲譽及管理專長擴大其客戶群，提高其資產管理服務質量，並增強核心產業優勢。
- (i) 建德及其附屬公司（統稱為「建德集團」）主要在中國從事物業開發業務。誠如建德於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 建德截至二零二四年六月三十日止六個月的未經審核收益及虧損分別約為人民幣 63,900,000 元及人民幣 3,800,000 元；及 (ii) 建德集團將繼續堅持審慎的管理方法，保持增長、效率及風險之間的平衡。建德集團致力於為客戶開發高品質的物業及生活社區，特別是在中國城市化進程不斷推進，對住房依然有堅實剛性需求的市場。建德集團亦將致力於以客戶為中心，不斷創新產品功能，實現客戶對美好生活的追求。年內，本集團出售其於建德 8,000,000 股股份的投資，並錄得已變現淨虧損約 119,000 港元。
- (j) 華能電力及其附屬公司（統稱為「華能電力集團」）從事在中國全國範圍內開發、建設和經營管理發電廠。誠如華能電力於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 華能電力截至二零二四年六月三十日止六個月的未經審核收益及虧損分別約為人民幣 118,805,900,000 元及人民幣 9,430,500,000 元；及 (ii) 華能電力集團將加強各地區天氣變化、電力供需形勢研判，抓住迎峰度夏、迎峰度冬的電力保供關鍵期，優化發電時序和發電結構，全力以赴爭取高價時段發電機機，多發效益電量。華能電力集團將密切跟蹤煤炭市場變化，努力提高長協合同履約率，充分發揮長協合同壓艙石作用。公司將把握國際煤炭市場形勢，做優進口煤；繼續優化供應結構，提升機組頂峰保供能力，強化庫存管理，發揮淡季儲存策略。華能電力集團將優化債務期限結構，努力控制融資成本，防範資金風險，實現降本增效。
- (k) 中芯國際及其附屬公司（統稱為「中芯國際集團」）主要從事電腦輔助設計、銷售及營銷、技術研發、製造、買賣集成電路及其他半導體服務，同時設計及製造半導體光罩。誠如中芯國際於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 中芯國際截至二零二四年六月三十日止六個月的未經審核收益及溢利分別約為 3,651,500,000 美元及 235,800,000 美元；及 (ii) 中芯國際集團產能布建穩中有進，重點項目成效初顯，合作生態加快建立，管理效能全面提升。

- (l) Tibet Water and its subsidiaries (collectively referred to as “Tibet Water Group”) are principally engaged in the production and sales of water products and beer products in PRC and provision of lending services to third parties in Hong Kong with relevant license. As disclosed in the interim report of Tibet Water for the six months ended 30 June 2024, (i) the unaudited revenue and profit of Tibet Water for the six months ended 30 June 2024 were approximately RMB138.8 million and RMB9.0 million respectively; and (ii) the Tibet Water Group would unwaveringly take the “5100” brand as the core of strategy, adhere to the brand reputation, uphold the brand concept and enhance the brand value. On the basis of maintaining and upholding the existing high-quality sales channels, the Tibet Water Group would accelerate the expansion of overseas markets, increase investment in production research and development, and strengthen product cost control. The Tibet Water Group will adhere to the dual-engine drive of water and beer, optimise the sales layout and enrich the product range. During the Year, the Group disposed of its investment in the shares of Tibet Water and recorded a net realised gain of approximately HK\$114,000.
- (m) Lumina and its subsidiaries (collectively referred to as “Lumina Group”) are principally engaged in the provision of fire safety services in Hong Kong. As disclosed in the interim report of Lumina for the six months ended 30 September 2024, (i) the unaudited revenue and loss of Lumina for the six months ended 30 September 2024 were approximately HK\$14.2 million and HK\$7.8 million respectively; and (ii) the Lumina Group is an established fire safety service provider in Hong Kong, focusing on building fire safety and has started to explore other business opportunities in the production of short videos and animation business in the PRC. The Lumina Group would continue to strengthen its market position, deliver more values to the customers and optimise its productivity and efficiency.
- (n) The principal activities of Hao Tian and its subsidiaries (collectively referred to as “Hao Tian Group”) include securities investment; provision of securities brokerage and other financial services; asset management; rental and trading of construction machinery; provision of repair and maintenance and transportation service; property development; and money lending. As disclosed in the interim report of Hao Tian for the six months ended 30 September 2024, (i) the unaudited revenue and loss of Hao Tian for the six months ended 30 September 2024 were approximately HK\$86 million and HK\$81 million respectively; (ii) the Hao Tian Group would continue to pursue a long-term business strategy of diversifying into financial services business, property development business, and construction machinery business. The Hao Tian Group would continue to expand the clients base and establish a strong track record in order to strengthen the businesses of corporate financial advisory services, asset management services and streamline the clients base and gradually phasing out the money lending business in the coming future. The Hao Tian Group is also deploying and looking for local high-quality projects, following the layout along the “One Belt, One Road” regions.
- (l) 西藏水資源及其附屬公司（統稱為「西藏水資源集團」）主要從事於中國生產及銷售水產品及啤酒產品，以及於香港擁有向第三方提供借款服務的相關牌照。誠如西藏水資源於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 西藏水資源截至二零二四年六月三十日止六個月的未經審核收益及溢利分別約為人民幣138,800,000元及人民幣9,000,000元；及(ii) 西藏水資源集團將堅定不移地以「5100」品牌為戰略核心，堅守品牌信譽，秉持品牌理念，提升品牌價值。在維持和維護現有優質銷售渠道的基礎上，西藏水資源集團將加速海外市場的拓展，加大產品研發的投入，加強產品成本的控制。西藏水資源集團將堅持水和啤酒雙引擎驅動，優化銷售佈局，豐富產品種類。年內，本集團出售其於西藏水資源股份的投資，並錄得已變現淨收益約114,000港元。
- (m) 瑩嵐及其附屬公司（統稱為「瑩嵐集團」）主要於香港從事提供消防安全服務。誠如瑩嵐於截至二零二四年九月三十日止六個月的中期報告所披露，(i) 瑩嵐截至二零二四年九月三十日止六個月的未經審核收益及虧損分別約為14,200,000港元及7,800,000港元；及(ii) 瑩嵐集團為聲譽昭著的香港消防安全服務供應商，專注於樓宇消防安全，且已開始探索於中國從事短片及動畫製作業務的其他商機。瑩嵐集團將繼續鞏固其市場地位，為客戶締造更大價值，以及優化生產力及效率。
- (n) 昊天及其附屬公司（統稱為「昊天集團」）的主要業務包括證券投資；提供證券經紀以及其他金融服務；資產管理；建築機械租賃及銷售；提供維修及保養以及運輸服務；物業發展；及放債。誠如昊天於截至二零二四年九月三十日止六個月的中期報告所披露，(i) 昊天截至二零二四年九月三十日止六個月的未經審核收益及虧損分別約為86,000,000港元及81,000,000港元；(ii) 昊天集團將繼續奉行長遠業務策略，多元化拓展至金融服務業務、物業發展業務及建築機械業務。昊天集團將繼續擴大客戶基礎及建立豐碩的往績記錄，以便在未來強化企業融資諮詢服務業務、資產管理服務業務及精簡放債服務業務的客戶層並逐步將借貸業務淘汰。按照「一帶一路」地區沿線佈局，昊天集團亦在部署並物色當地優質項目。

- (o) As an information technology ("IT") solutions provider, MTT and its subsidiaries (collectively referred to as "MTT Group") primarily engages in (i) the distribution of IT products in Hong Kong, Macau and the PRC; and (ii) provision of system integrated solutions for IT systems involving integration of system design, development and/or implementation of hardware and software, hardware and software coordination, system configuration and technical and maintenance support service ("SI solutions") in Hong Kong, the PRC and Macau. The MTT Group operates in (i) the distribution business as an authorised distributor sourcing IT products from IT product vendors and distributing to down-stream resellers; and (ii) SI solutions business as an SI solutions provider procuring IT products from authorised distributors, integrating them into customised solutions and selling them to end-users. As disclosed in the interim report of MTT for the six months ended 30 September 2024, the unaudited revenue and loss of MTT for the six months ended 30 September 2024 were approximately HK\$220.3 million and HK\$18.2 million respectively. During the Year, the Group disposed of its investment in the shares of MTT and recorded a net realised loss of approximately HK\$25,000.
- (p) Runhua Living and its subsidiaries (collectively referred to as "Runhua Living Group") are principally engaged in property development in the PRC. The services provided by the Runhua Living can be broadly divided into four business segments by their nature, namely property management services; property engineering and landscape construction services; leasing services from investment properties; and other services. As disclosed in the interim report of Runhua Living for the six months ended 30 June 2024, (i) the unaudited revenue and profit of Runhua Living for the six months ended 30 June 2024 were approximately RMB407.5 million and RMB17.5 million respectively; and (ii) the Runhua Living Group would plans to increase its market share in cities within Shandong Province where it has already conducted business through acquisitions and business partnerships, and to enter other nearby developed markets such as the Yangtze River Delta and the Beijing-Tianjin-Hebei region through the acquisition of well-known local property management companies. During the Year, the Group disposed of its investment in the 150,000 shares of Runhua Living and recorded a net realised loss of approximately HK\$94,000.
- (q) IBO and its subsidiaries (collectively referred to as "IBO Group") are principally engaged in the sale of radio frequency identification equipment and electronic products, provision of system maintenance services, development of customised softwares and provision of coordination, management and installation services of smart cities. As disclosed in the interim report of IBO for the six months ended 30 September 2023, (i) the unaudited revenue and loss of IBO for the six months ended 30 September 2023 were approximately RMB199 million and RMB150.0 million respectively; (ii) the IBO Group expects to concentrate its resources to address the strong demand of the electronic cigarette market in the PRC; and (iii) the trading of the shares of IBO on the Main Board of the Stock Exchange has been suspended from 29 April 2024.
- (r) HG and its subsidiaries (collectively referred to as "HG Group") are principally engaged in the design, development, manufacturing, subcontracting service and sales of semiconductor products, including light emitting diode ("LED") beads, gallium nitride ("GaN") chips, GaN components and related application products, and fast charging products in the PRC. As disclosed in the interim report of HG for the six months ended 30 June 2024, (i) the unaudited revenue and loss of HG for the six months ended 30 June 2024 were approximately RMB34.3 million and RMB57.2 million respectively; and (ii) the HG Group would continue to make increased efforts to develop the third-generation semiconductor GaN industry chain in order to accelerate the pace of R&D, and to expand the applications of GaN-related products. The HG Group would also actively seek strategic partners and upgrade its industrial chain while upholding the principle of achieving synergy in the use of resources. During the Year, the Group disposed of its investment in the 100,000 shares of HG and recorded a net realised loss of approximately HK\$328,000.
- (o) 作為資訊科技（「資訊科技」）解決方案供應商，數科及其附屬公司（統稱為「數科集團」）主要從事 (i) 於香港、澳門及中國內地分銷資訊科技產品；及 (ii) 於香港、中國內地及澳門提供有關資訊科技系統的系统整合解決方案，當中涉及整合系統設計、硬件及軟件開發及／或實施、硬件及軟件協調、系統配置以及技術及維護支援服務（「系統整合解決方案」）。數科集團經營 (i) 分銷業務，作為授權分銷商向資訊科技產品廠商採購資訊科技產品再分銷予下游經銷商；及 (ii) 系統整合解決方案業務，作為系統整合解決方案供應商向授權分銷商採購資訊科技產品，整合成定製的解決方案再轉售予終端用戶。誠如數科於截至二零二四年九月三十日止六個月的中期報告所披露，數科截至二零二四年九月三十日止六個月的未經審核收益及虧損分別約為 220,000 港元及 18,200,000 港元。年內，本集團出售其於數科股份的投資，並錄得已變現淨虧損約 25,000 港元。
- (p) 潤華生活及其附屬公司（統稱為「潤華生活集團」）主要於中國從事物業開發業務。潤華生活提供的服務按其性質大致可分為四個業務分部，即物業管理服務；物業工程及園林建設服務；投資物業的租賃服務；及其他服務。誠如潤華生活於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 潤華生活截至二零二四年六月三十日止六個月的未經審核收益及溢利分別約為人民幣 407,500,000 元及人民幣 17,500,000 元；及 (ii) 潤華生活集團計劃透過收購以及與業務合作夥伴進行業務合作的方式增加在其已開展業務的山東省內城市的市場份額，並透過收購當地知名的物業管理公司進軍其他臨近的發達市場，如長江三角洲及京津冀地區。年內，本集團出售其於潤華生活 150,000 股股份的投資，並錄得已變現淨虧損約 94,000 港元。
- (q) 艾伯及其附屬公司（統稱為「艾伯集團」）主要從事銷售射頻識別設備及電子產品、提供系統維護服務、開發定制軟件及提供智慧城市協調、管理及安裝服務。誠如艾伯於截至二零二三年九月三十日止六個月的中期報告所披露，(i) 艾伯截至二零二三年九月三十日止六個月的未經審核收益及虧損分別約為人民幣 199,000,000 元及人民幣 150,000,000 元；(ii) 艾伯集團期望集中其資源以應對中國電子煙市場的殷切需求；及 (iii) 艾伯股份自二零二四年四月二十九日起於聯交所主板暫停買賣。
- (r) 宏光及其附屬公司（統稱為「宏光集團」）主要於中國從事設計、開發、製造、分包服務及銷售半導體產品，包括發光二極管（「LED」）燈珠、氮化鎵（「GaN」）芯片、GaN 器件及其相關應用產品以及快速電池充電產品。誠如宏光於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 宏光截至二零二四年六月三十日止六個月的未經審核收益及虧損分別約為人民幣 34,300,000 元及人民幣 57,200,000 元；及 (ii) 宏光集團將繼續加大力度完善第三代半導體 GaN 產業鏈，務求加快步伐研發及拓展 GaN 相關產品的應用。宏光集團同時將積極尋求戰略合作夥伴，秉持資源互補的原則，實現其產業鏈升級。年內，本集團出售其於宏光 100,000 股股份的投資，並錄得已變現淨虧損約 328,000 港元。

- (s) Hang Tai Yue and its subsidiaries (collectively referred to as “Hang Tai Yue Group”) are principally engaged in provision of hospitality and related services in Australia; money lending business and assets investments business. As disclosed in the interim report of Hang Tai Yue for the six months ended 30 June 2024, (i) the unaudited revenue and loss of Hang Tai Yue for the six months ended 30 June 2024 were approximately HK\$38.1 million and HK\$23.7 million respectively; and (ii) the Hang Tai Yue Group would continue to carry on its existing businesses by formulation and implementation of its own business plans and strategies and leveraging its own business model, competitiveness and strengths so as to develop, maintain and enhance its existing businesses, which will be viable and sustainable and will be able to create value and investment return.
- (t) China Demeter and its subsidiaries (collectively referred to as “China Demeter Group”) are principally engaged in provision of loan financing in Hong Kong; provision of financial services (including advising and dealing in securities and asset management); investment in listed and unlisted securities; provision of food and beverage services; alcoholic beverage distribution and miscellaneous business; and provision of children education services. As disclosed in the interim report of China Demeter for the six months ended 30 June 2024, (i) the unaudited revenue and loss of China Demeter for the six months ended 30 June 2024 were approximately HK\$68.8 million and HK\$12 million respectively; and (ii) the China Demeter Group would adopt cost control measures and implemented several marketing campaigns aimed at increasing client engagement with its products and services. The China Demeter Group would employ a cautious approach regarding the loan-to-value ratio of collaterals and the quality of margin finance clients to limit exposure for our margin financing and money lending businesses.
- (u) Hanvey and its subsidiaries (collectively referred to as “Hanvey Group”) are principally engaged in the design and development, manufacturing and distribution of watch products on original design manufacturing basis for watch manufacturers, brand owners and watch importers across the globe. As disclosed in the interim report of Hanvey for the six months ended 30 June 2024, (i) the unaudited revenue and loss of Hanvey for the six months ended 30 June 2024 were approximately HK\$51.8 million and HK\$9.0 million respectively; and (ii) the Hanvey Group would continue to focus on the core business and to in strengthen our product design and development capability in order to maximise the long term returns of the shareholders.
- (s) 恆泰裕及其附屬公司（統稱為「恆泰裕集團」）主要從事於澳洲提供酒店及相關服務；借貸業務及資產投資業務。誠如恆泰裕於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 恆泰裕截至二零二四年六月三十日止六個月的未經審核收益及虧損分別約為 38,100,000 港元及 23,700,000 港元；及 (ii) 恆泰裕集團將繼續通過制定及實施自身的業務計畫與策略，利用自身的業務模式、競爭力及優勢開展其現有業務，進而發展、保持並加強現有業務。通過以上可行且可持續的方式，將可創造價值及帶來投資回報。
- (t) 國農及其附屬公司（統稱為「國農集團」）主要從事於香港提供貸款融資；提供金融服務（包括就證券提供意見及證券交易以及提供資產管理）；投資上市及非上市證券；提供食品及飲料服務；酒精飲料分銷及雜項業務；及提供兒童教育服務。誠如國農於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 國農截至二零二四年六月三十日止六個月的未經審核收益及虧損分別約為 68,800,000 港元及 12,000,000 港元；及 (ii) 國農集團將採取成本控制措施，並推出多項營銷活動，旨在提高客戶對其產品及服務的接觸。國農集團對抵押品按揭成數及保證金融資客戶質素採取審慎方針，限制保證金融資及放債業務的風險敞口。
- (u) 恆偉及其附屬公司（統稱為「恆偉集團」）主要從事按原設計製造基準為全球手錶製造商、品牌擁有人及手錶進口商設計及開發、製造及分銷手錶產品。誠如恆偉於截至二零二四年六月三十日止六個月的中期報告所披露，(i) 恆偉截至二零二四年六月三十日止六個月的未經審核收益及虧損分別約為 51,800,000 港元及 9,000,000 港元；及 (ii) 恆偉集團將繼續專注發展核心業務，並改進產品設計及加強開發能力，為股東帶來最大的長遠回報。

During the Year, dividend income received by the Group from its investments in listed securities that were held for trading was approximately HK\$7,000 (2023: Nil). Resulting from the volatile conditions of the Hong Kong stock market and the financial performance of its respective investee companies, a net fair value loss on financial assets at fair value through profit or loss of approximately HK\$4,409,000 (2023: gain of approximately HK\$1,965,000) was recognised by the Group for its securities investments for the Year.

於年內，本集團收到持作買賣的上市證券投資的股息收入約 7,000 港元（二零二三年：無）。由於香港股市的波動狀況及其各投資公司之財務表現，於年內本集團就其證券投資確按公平價值計入損益的金融資產的公平價值虧損淨額約為 4,409,000 港元（二零二三年：收益約 1,965,000 港元）。



The objective of the Group's investments in the listed securities in Hong Kong is to achieve profit from the appreciation of the market value of its invested securities and to receive dividend income. The Directors expect that the stock market in Hong Kong will remain volatile which may affect the performance of the Group's securities investments. The Board believes that the performance of the securities investments of the Group will be dependent on the financial and operating performance of the investee companies and the market sentiment, which are affected by factors, such as interest rate movements and performance of the macro economy. The Group will continue to adopt a conservative investment approach in its trading of listed securities in the Hong Kong stock market and closely monitor the performance of its securities investment portfolio.

### Other investments

As at 31 December 2024, none of each of the Group's investments had a value of 5% or more of the Company's total assets and the Group's investments included the following investments:

#### (a) *Listed equity investment (not held for trading) – China Parenting Network Holdings Limited (“CPN”)*

As at 31 December 2024, the Group held 3,307,600 ordinary shares of CPN (“CPN Shares”), the issued shares of which are listed on the Main Board of the Stock Exchange (Stock Code: 1736), being approximately 0.96% of the total issued shares of CPN. CPN, together with its subsidiaries, operate an online platform focusing on the CBM (children, babies, and maternity) market in the PRC and are mainly engaged in (i) the provision of marketing and promotional services through its platform; and (ii) sales of goods in the PRC. The Group will continue to hold the CPN Shares for dividend income.

The CPN Shares were measured at fair value at approximately HK\$265,000 as at 31 December 2024, based on their last closing price quoted on the Stock Exchange. During the Year, no fair value loss of the CPN Shares recognised to the financial assets measured at fair value through other comprehensive income reserve of the Group (2023: approximately HK\$99,000). During the Year, no dividend income was received from this investment (2023: Nil).

本集團於香港上市證券投資的目的乃從其投資證券的市值升值中獲取溢利及獲得股息收入。董事預期香港股市將持續波動，其或會影響本集團證券投資的表現。董事會相信，本集團證券投資的表現將取決於被投資公司的財務及營運表現以及市場氣氛，而該等方面受利率變動及宏觀經濟表現等因素影響。本集團將繼續採用謹慎的投資策略買賣香港股市的上市證券，並密切監控其證券投資組合的表現。

### 其他投資

於二零二四年十二月三十一日，本集團之各投資價值概無佔有本公司總資產的 5% 或以上及本集團之投資包括以下投資：

#### (a) *上市股本投資（並非持作買賣）－中國育兒網絡控股有限公司（「中國育兒網絡」）*

於二零二四年十二月三十一日，本集團持有中國育兒網絡（其已發行股份於聯交所主板上市，股份代號：1736）3,307,600 股普通股（「中國育兒網絡股份」），即中國育兒網絡全部已發行股份的約 0.96%。中國育兒網絡及其附屬公司經營一個專注於中國孕嬰童市場之網絡平台，主要從事 (i) 透過其平台提供營銷及推廣服務；及 (ii) 在中國銷售貨品。本集團將繼續持有中國育兒網絡股份以獲取股息收入。

於二零二四年十二月三十一日，基於聯交所的當時所報最近收市價，中國育兒網絡股份按公平價值計量約為 265,000 港元。於年內，並無確認至本集團按公平價值計入其他全面收入的金融資產之儲備的中國育兒網絡股份的公平價值虧損（二零二三年：約 99,000 港元）。於年內，並無從該投資收取股息收入（二零二三年：無）。

### **(b) Investment in an associate – Square Box Limited (“Square Box”)**

As at 31 December 2024, the Group held 100% interests in Infinite Capital Ventures Limited, which in turn held 50% equity interest in Square Box. Square Box is principally engaged in the design, development and management of mobile applications, which serve as social network platform that focuses on child development and family activities, including arrangement of extra-curricular activities for kids and enabling parents to check the admission schedule of schools and receive parental news. During the Year, the loss of Square Box shared by the Group was nil (2023: approximately HK\$276,000). Looking ahead, the Group will continue to monitor the operations of Square Box for the improvement of its financial performance. As at 31 December 2024, the carrying amount of the Group’s investment in Square Box, an associate of the Group, was nil (2023: approximately nil).

### **(c) Investment in a joint venture – Sky View Investment Limited (“Sky View”)**

As at 31 December 2024, the Group held 49% interest in Sky View, this investment was recorded by the Group as an investment in a joint venture as at 31 December 2024. During the Year, the Group shared the loss of Sky View of approximately HK\$13,000 (2023: approximately HK\$10,000). As at 31 December 2024, the carrying amount of the Group’s investment in this joint venture was approximately HK\$70,000 (2023: approximately HK\$83,000).

### **(b) 於一間聯營公司之投資 – Square Box Limited (「Square Box」)**

於二零二四年十二月三十一日，本集團持有 Infinite Capital Ventures Limited 的全部權益，而 Infinite Capital Ventures Limited 持有 Square Box 的 50% 股權。Square Box 主要從事手機應用程式之設計、開發及管理，該等應用程式乃作為專注於孩童發展及家庭活動的社交網絡平台，功能包括為孩童安排課外活動及方便家長查看學校入學時間表及接收家長消息。於年內，本集團應佔 Square Box 的虧損為零（二零二三年：約 276,000 港元）。展望未來，本集團將繼續監控 Square Box 的營運，以改善其財務表現。於二零二四年十二月三十一日，本集團於其聯營公司 Square Box 之投資的賬面值約為零（二零二三年：約零）。

### **(c) 於一間合營公司之投資 – 天匯投資有限公司 (「天匯」)**

於二零二四年十二月三十一日，本集團持有天匯 49% 權益，於二零二四年十二月三十一日，本集團將該投資入賬列作一間合營公司之投資。於年內，本集團應佔天匯虧損約 13,000 港元（二零二三年：約 10,000 港元）。於二零二四年十二月三十一日，本集團於該合營公司之投資的賬面值約為 70,000 港元（二零二三年：約 83,000 港元）。

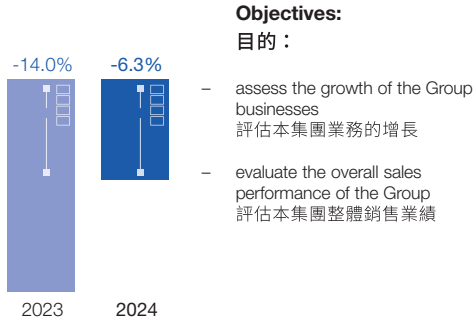

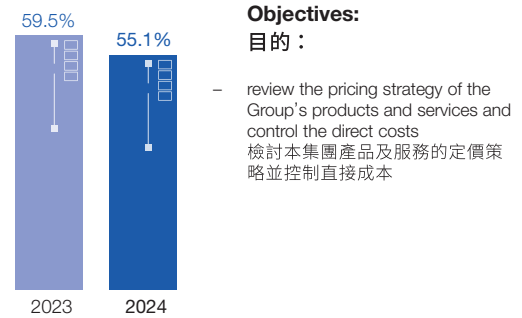
#### Revenue growth rate (%)

收益增長率(%)



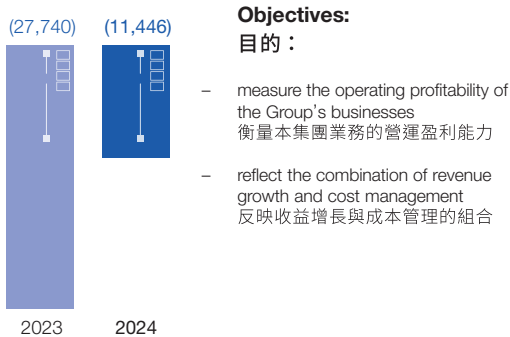
#### Gross profit margin (%)

毛利率(%)



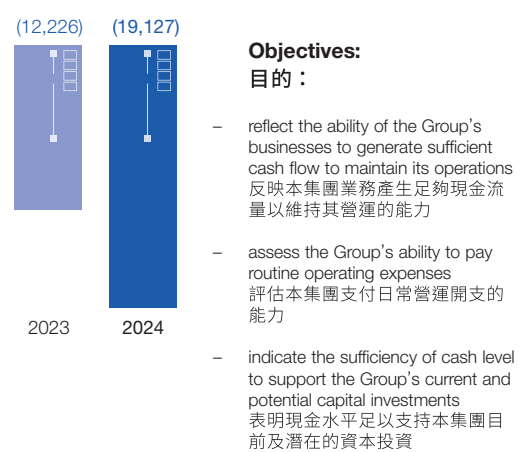
#### Loss before taxation (HK\$'000)

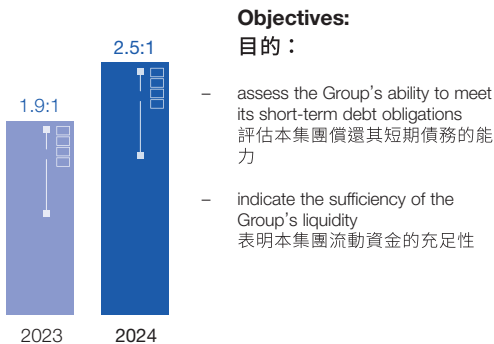
#### Operating cash inflow/(outflow) (HK\$'000)

### Revenue, gross profit and gross profit margin

Revenue of the Group for the Year was approximately HK\$49,055,000 (2023: approximately HK\$52,326,000), representing a decrease of approximately 6.3% as compared to that of the last financial year. Such decrease was mainly due to (i) the decrease in the revenue generated from the Group's financial software solutions business, which was affected by the local stagnant and conservative economic sentiment as well as fierce market competition; and (ii) the increase in the revenue generated from the money lending business during the Year. In light of the increasing number of new borrowing clients, there was an increase in the interest income generated by the Group from its money lending business during the Year.

Gross profit of the Group for the Year was approximately HK\$27,009,000 (2023: approximately HK\$31,146,000), representing a decrease of approximately 13.3% as compared to that of the last financial year, which was in line with the decrease in revenue. Gross profit margin of the Group for the Year was approximately 55.1% (2023: approximately 59.5%). Such decrease in the gross profit and the gross profit margin of the Group was mainly due to the decrease in the gross profit margin of the financial trading software solutions business.

### Administrative expenses

The Group's administrative expenses for the Year amounted to approximately HK\$36,726,000 (2023: approximately HK\$51,787,000), representing a decrease of approximately 29.1% as compared to that of the last financial year. The decrease in the administrative expenses was due to the implementation of cost control and efficiency enhancement measures by the Group during the Year.

### Loss for the year

The Group recorded a net loss after tax of approximately HK\$12,338,000 for the Year (2023: approximately HK\$28,346,000), which had decreased by approximately 56.5%. The decrease in net loss was mainly due to the net effect of: (i) the decrease in the gross profit of the Group for the Year from approximately HK\$31,146,000 for the year ended 31 December 2023 to approximately HK\$27,009,000 for the Year; (ii) the turnaround of the net fair value gain on financial assets at fair value through profit or loss of approximately HK\$1,965,000 for the year ended 31 December 2023 to a net fair value loss of approximately HK\$4,409,000 for the Year; (iii) the turnaround of the provision of impairment loss on loans and interest receivables of approximately HK\$7,057,000 recognised for the year ended 31 December 2023 to the reversal of provision of impairment loss on loans and interest receivables of approximately HK\$2,901,000 recognised for the Year; and (iv) the decrease in the administrative expenses incurred by the Group for the Year as mentioned above.

### 收益、毛利及毛利率

本集團於年內之收益約為 49,055,000 港元（二零二三年：約 52,326,000 港元），較上一個財政年度減少約 6.3%。該減少主要是由於 (i) 本集團的金融軟件解決方案業務收入減少，乃受到當地經濟停滯不前及保守的經濟的情緒以及市場競爭激烈的影響；及 (ii) 年內借貸業務產生的收入增加。年內，鑒於新增借貸客戶數目不斷增加，本集團自借貸業務產生的利息收入增加。

本集團於年內之毛利約為 27,009,000 港元（二零二三年：約 31,146,000 港元），較上一個財政年度減少約 13.3%，與收益減少一致。本集團於年內之毛利率約為 55.1%（二零二三年：約 59.5%）。本集團的毛利及毛利率的有關減少乃主要由於金融交易軟件解決方案業務的毛利率減少。

### 行政開支

本集團於年內之行政開支約為 36,726,000 港元（二零二三年：約 51,787,000 港元），較上一個財政年度減少約 29.1%。行政開支減少乃由於年內本集團實施控本增效措施。

### 年內虧損

本集團於年內錄得除稅後虧損淨額約 12,338,000 港元（二零二三年：約 28,346,000 港元），已減少約 56.5%。誠如上文所述，虧損淨額減少主要受到：(i) 本集團本年度毛利由截至二零二三年十二月三十一日止年度的約 31,146,000 港元減少至本年度的約 27,009,000 港元；(ii) 按公平價值計入損益的金融資產之公允價值收益淨額由截至二零二三年十二月三十一日止年度的約 1,965,000 港元轉為本年度的公允價值虧損淨額約 4,409,000 港元；(iii) 應收貸款及利息之減值虧損撥備由截至二零二三年十二月三十一日止年度確認的約 7,057,000 港元轉為本年度確認的應收貸款及利息減值虧損撥備撥回約 2,901,000 港元；及 (iv) 如上文所述本年度本集團產生的行政開支減少的淨影響所致。

### FINANCIAL RESOURCES, LIQUIDITY AND CAPITAL STRUCTURE

As at 31 December 2024, the Group's cash and bank balances were approximately HK\$10,857,000 (2023: approximately HK\$9,214,000). The net current assets of the Group as at 31 December 2024 amounted to approximately HK\$40,902,000 (2023: approximately HK\$24,709,000). As at 31 December 2024, approximately 99.3% of the Group's cash and cash equivalents were denominated in Hong Kong dollars, while the remaining balance was denominated in Renminbi. The current ratio of the Group, which was defined as total current assets divided by total current liabilities, was approximately 2.5 times as at 31 December 2024 (2023: approximately 1.9 times). The Group's working capital is sufficient to meet its operational needs and capital commitments, if any.

As at 31 December 2024, the Group's total borrowing only comprised bank finance lease amounting to approximately HK\$692,000 (2023: approximately HK\$1,045,000) with annual effective interest rate at 4.83% (2023: 4.83%) and denominated in Hong Kong dollars. The Group's bank finance lease will mature and will be settled on 27 October 2026. As at 31 December 2024, the gearing ratio of the Group, which was defined as total borrowing divided by total assets, was approximately 0.01 (2023: approximately 0.02).

As at 31 December 2024, the Group had shareholders' equity of approximately HK\$51,709,000 (2023: approximately HK\$37,536,000). As at 31 December 2024, the capital of the Company comprised ordinary shares only.

Save for the rights issue as set out in the paragraph headed "Issue of shares" in the report of the Directors in this annual report, the Company did not carry out any fund raising activities by issuing new shares of the Company during the Year (2023: Nil).

### TREASURY AND FUNDING POLICIES

The Group adopts a prudent approach with respect to its treasury and funding policies, and its financial and fundraising activities are subject to effective management and supervision. The Group manages its capital to ensure that the entities in the Group will be able to continue as a going concern while maximising the return to the shareholders of the Company ("Shareholders") through optimisation of the debt and equity balance.

### FOREIGN EXCHANGE EXPOSURE

During the years ended 31 December 2024 and 2023, the business activities of the Group were mainly denominated in Hong Kong dollars. The Directors did not consider the Group was exposed to any significant foreign currency exchange risks. During the Year, the Group did not adopt any financial instruments for hedging purposes.

### 財務資源、流動資金及資本架構

於二零二四年十二月三十一日，本集團借貸總額僅包括銀行融資租賃約 692,000 港元（二零二三年：約 1,045,000 港元），年實際利率為 4.83%（二零二三年：4.83%），以港元計值。本集團的銀行融資租賃將於二零二六年十月二十七日期滿及付訖。於二零二四年十二月三十一日，本集團的資產負債率（借貸總額除以資產總值）約為 0.01（二零二三年：約 0.02）。

於二零二四年十二月三十一日，本集團之股東權益約為 51,709,000 港元（二零二三年：約 37,536,000 港元）。於二零二四年十二月三十一日，本公司資本僅包括普通股。

除本年報中董事會報告「發行股份」一段所載供股外，本公司於年內並無透過發行本公司新股份進行任何籌資活動（二零二三年：無）。

### 財政及資金政策

本集團對財政及資金政策採取審慎的態度，且財務及籌資活動均受到有效管理及監督。本集團管理其資本以確保本集團實體將能夠持續經營，同時透過優化債務及權益結餘，為本公司股東（「股東」）回報實現最大化。

### 外匯風險

截至二零二四年及二零二三年十二月三十一日止年度，本集團之業務活動主要以港元計值。董事認為本集團並無承受任何重大外匯風險。於本年度，本集團並無採用任何對沖金融工具。

The Group did not have any material acquisition or disposal transaction during the Year.

### FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

As at the date of this annual report, the Group does not have any concrete plan for material investments or capital assets for the coming year. Nonetheless, if any acquisition opportunity arises or is identified in the coming year, the Group will conduct a feasibility study and prepare implementation plans to consider whether it is beneficial to the Company and the Shareholders as a whole.

### DIVIDEND

The Board does not recommend the payment of any dividend for the Year (2023: Nil).

### EMPLOYEE AND REMUNERATION POLICY

As at 31 December 2024, the Group had 66 employees (2023: 69). The Group continues to maintain and upgrade the capabilities of its workforce by providing them with adequate and regular training. The Group remunerates its employees mainly based on industry practices and individual performance and experience. On top of regular remuneration, discretionary bonus and share options may be granted to eligible staff by reference to the Group's performance as well as the individual performance. Total employee benefits expense, including directors' emoluments, was approximately HK\$37,264,000 for the Year (2023: approximately HK\$42,936,000).

The remuneration of the Directors is determined by the Board, under the recommendation from the remuneration committee (“Remuneration Committee”) of the Company, with reference to the background, qualification, experience, duties and responsibilities of the respective Directors within the Group and the prevailing market conditions.

## PRINCIPAL RISKS AND UNCERTAINTIES

### Operational risks

The Group is exposed to operational risks in relation to each business division of the Group. To manage the operational risks, the management of each business division of the Group is responsible for monitoring the operation and assessing the operational risks of their respective business divisions. They are responsible for implementing the Group’s risk management policies and procedures and shall report any irregularities in connection with operation to the Directors and seek for directions. The Group emphasises on ethical value and prevention of fraud and bribery and has established a whistleblower program, including communication with other departments and business divisions and units, to report any irregularities. In this regard, the Directors consider that the Group’s operational risks have been effectively mitigated.

### Financial risks

The Group is exposed to market risks (particularly price risks), credit risks and liquidity risks, details of which are set out in note 6 to the consolidated financial statements.

## PROSPECT

Under the heightened geopolitical uncertainties, followed by the sluggish property market in Hong Kong, the risk appetite for corporate investment, business expansion and personal consumption is expected to remain conservative in the near future.

The Group will continue to stay resilient and strengthen its footprint in the IT industry, with an aim to providing customers with the greatest service and technology. In order to diversify the source of income, the Group will continue to seek for opportunities in providing other IT services, including but not limited to services related to artificial intelligence, blockchain technology, application development, etc.. The Group will capitalise on its strong business foundation and network to actively explore suitable investment opportunities with an appropriate balance between risks and opportunities so as to generate returns for the Shareholders.

The money lending business is another core business segment of the Group. In view of the instability of the financial market and the economic environment in Hong Kong, the Group will implement a prudent approach in granting new loans and collect the loans it has granted and the related interest receivables from the borrowers in an active manner.

### 金融風險

本集團面臨市場風險（尤其是價格風險）、信貸風險及流動資金風險，有關詳情載於綜合財務報表附註 6。

### 展望

於地緣政治不確定性增加的情況下，香港房地產市場疲軟，預計短期內企業投資、業務擴張及個人消費的風險偏好仍趨於保守。

本集團將繼續保持堅韌不拔的精神，鞏固其在信息技術行業的地位，為客戶提供最優質的服務和技術。為多樣化收入來源，本集團將繼續尋求提供其他資訊科技服務的機遇，包括但不限於人工智能、區塊鏈技術、應用開發等相關服務。本集團將依託紮實的業務基礎及網絡，積極探索合適的投資良機，並在風險和機遇之間取得適當的平衡，為股東帶來回報。

借貸業務為本集團另一項核心業務分部。鑒於香港金融市場及經濟環境的不穩定局面，本集團將採取審慎的方式授出新貸款，並以積極的方式收回其授出的貸款及應收借款人的相關利息。

### BOARD OF DIRECTORS

#### Composition of the Board

From 1 January 2024 and up to the date of this annual report, the Board consisted of three executive Directors namely Ms. Tin Yat Yu Carol (former name as Tin Yuen Sin Carol), Ms. Liu Mung Ting and Ms. Lin Ting, and three independent non-executive Directors namely Mr. Hon Ming Sang, Ms. Lee Kwun Ling, May Jean and Mr. Tang Shu Pui Simon.

The Board was chaired by Ms. Tin Yat Yu Carol (former name as Tin Yuen Sin Carol) during the Year and as at the date of this annual report.

As at the date of this annual report, save that Ms. Liu Mung Ting, an executive Director and the chief executive officer of the Company (“Chief Executive Officer”), is a daughter of Ms. Tin Yat Yu Carol (former name as Tin Yuen Sin Carol), an executive Director and the chairman of the Board (“Chairman”), none of the Directors had any relationship (including financial, business, family or other material/relevant relationship) with each other.

The biographical details of all the Directors are set out on pages 45 to 49 of this annual report.

### Functions and responsibilities of the Board

The Board is collectively responsible for overseeing the management of business, strategic decisions and financial performance of the Company for the best interests of the Shareholders. The Board has established various Board committees and has delegated to these Board committees various responsibilities as set out in their respective terms of reference. All Directors have carried out their duties in good faith and in compliance with the standards of applicable laws and regulations, and have acted in the interests of the Company and the Shareholders as a whole at all times.

The Board takes responsibility for all major matters of the Company, including the approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (particularly those that may involve conflicts of interest), financial information, appointment of Directors and other significant financial and operational matters.

During the Year, 6 Board meetings were held to perform the abovementioned duties and responsibilities and details of attendance of each Board member are set out in the section headed "Attendance of Directors at Meetings" on page 40 of this annual report.

All Directors have full and timely access to all relevant information as well as the advice and services of the company secretary of the Company ("Company Secretary"), with a view to ensuring that the Board's procedures and all applicable rules and regulations are followed. Each Director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board.

### Delegation of powers

The Board delegates the day-to-day management authority, administration and operation of the Group to the executive Directors, the Chief Executive Officer and the senior management of the Group, while reserving certain key matters in strategic decision making for its approval. When the Board delegates certain aspects of its management and administration functions to management, it gives clear directions as to the powers of management, in particular, with respect to the circumstances where management needs to report back to and obtains prior approval from the Board before making decisions or entering into any commitments on behalf of the Group. During the Year, the executive Directors and the Chief Executive Officer, who also represented the senior management of the Group, provided all members of the Board with monthly updates pursuant to code provision D.1.2 of the CG Code while the Board regularly reviewed its arrangement on delegation of authority and responsibilities to ensure that such delegations are appropriate in view of the Group's prevailing circumstances.

### 董事會職能及責任

全體董事均可全面適時取得所有相關資料以及本公司公司秘書（「公司秘書」）提供之意見及服務，以確保符合董事會程序以及遵守所有適用規則及規例。一般而言，向董事會提出要求後，各董事均可於適當情況下徵詢獨立專業意見，費用由本公司承擔。

### 授出權力

董事會將本集團日常管理權力、行政及經營交由本集團之執行董事、行政總裁及高級管理層處理，同時保留若干關鍵戰略決策事宜，留待董事會批准。董事會將其若干管理及行政職能交予管理層，董事會對管理層的權力有清晰指示，特別是於管理層須向董事會匯報並事先向其取得批准方可作出決定或代表本集團訂立任何承擔之情況。於年內，執行董事及行政總裁（亦即本集團高級管理層）已根據企業管治守則之守則條文第 D.1.2 條向全體董事會成員提交每月更新資料，而董事會已定期檢討其權力及職責轉授安排，以確保有關轉授就本集團現況而言屬適當。

### Directors' appointment and re-election

The appointment of a new Director is made on the recommendation of the nomination committee ("Nomination Committee") of the Company or by the Shareholders in general meetings. Any Director appointed by the Board to fill a casual vacancy or as an additional Director shall hold office only until the first annual general meeting of the Company after his/her appointment and shall then be eligible for re-election.

Ms. Tin Yat Yu Carol (former name as Tin Yuen Sin Carol), an executive Director and the Chairman, had entered into a service contract with the Company for a term of one year from 1 January 2024 to 31 December 2024 (both days inclusive) and has been re-appointed for a term of one year on the same terms commencing on 1 January 2025 and ending on 31 December 2025 (both days inclusive).

Ms. Liu Mung Ting (an executive Director and the Chief Executive Officer) has entered into a service contract with the Company for a term from 7 July 2023 to 31 December 2024 (both days inclusive) and has been re-appointed for a term of one year on the same terms commencing on 1 January 2025 and ending on 31 December 2025 (both days inclusive).

Ms. Lin Ting (an executive Director) has entered into a service contract with the Company for a term of one year from 1 January 2024 to 31 December 2024 (both days inclusive) and has been re-appointed for a term of one year on the same terms commencing on 1 January 2025 and ending on 31 December 2025 (both days inclusive).

Each of the independent non-executive Directors namely Mr. Hon Ming Sang and Ms. Lee Kwun Ling, May Jean, has entered into an appointment agreement with the Company for a term of one year from 1 January 2024 to 31 December 2024 (both days inclusive), and has been re-appointed for a term of one year on the same terms commencing on 1 January 2025 and ending on 31 December 2025 (both days inclusive), which is in compliance with code provision B.2.2 of the CG Code.

Mr. Tang Shu Pui Simon (an independent non-executive Director) has entered into an appointment agreement with the Company for a term of from 7 July 2023 to 31 December 2024 (both days inclusive), and has been re-appointed for a term of one year on the same terms commencing on 1 January 2025 and ending on 31 December 2025 (both days inclusive).

All Directors are subject to retirement by rotation at least once every three years pursuant to code provision B.2.2 of the CG Code. By virtue of article 112 of the articles of association of the Company, the Board shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or as an additional Director provided that the number of Directors so appointed shall not exceed the maximum number determined from time to time by the Shareholders in general meeting of the Company.

### 董事委任及重選

廖夢婷女士(執行董事兼行政總裁)已與本公司訂立服務合約，自二零二三年七月七日起至二零二四年十二月三十一日止(包括首尾兩日)，並已按相同條款獲續聘，自二零二五年一月一日起至二零二五年十二月三十一日止(包括首尾兩日)為期一年。

林靈女士(執行董事)已與本公司訂立服務合約，自二零二四年一月一日起至二零二四年十二月三十一日止(包括首尾兩日)為期一年，並已按相同條款獲續聘，自二零二五年一月一日起至二零二五年十二月三十一日止(包括首尾兩日)為期一年。

獨立非執行董事(即韓銘生先生及李筠翎女士)各自已與本公司訂立委任協議，自二零二四年一月一日起至二零二四年十二月三十一日止(包括首尾兩日)為期一年，並已按相同條款獲續聘，自二零二五年一月一日起至二零二五年十二月三十一日止(包括首尾兩日)為期一年，符合企業管治守則守則條文第 B.2.2 條。

鄧澍培先生(獨立非執行董事)已與本公司訂立委任協議，自二零二三年七月七日起至二零二四年十二月三十一日止(包括首尾兩日)，並已按相同條款獲續聘，自二零二五年一月一日起至二零二五年十二月三十一日止(包括首尾兩日)為期一年。

根據企業管治守則守則條文第 B.2.2 條，全體董事均須至少每三年輪值退任一次。根據本公司組織章程細則第 112 條，董事會有權不時及隨時委任任何人士為董事填補董事會之臨時空缺或作為增補董事，惟所委任之董事人數不得超過股東於本公司股東大會上不時釐定之上限。

Pursuant to article 108(a) of the articles of association of the Company, at each annual general meeting of the Company, one-third of the Directors for the time being shall retire from office by rotation and all such retiring Directors, being eligible, will offer themselves for re-election. Details of the Directors to be retired by rotation and, where applicable, subject to re-election at the forthcoming annual general meeting of the Company will be contained in the circular to be despatched to the Shareholders in due course. None of the Directors who are being proposed for re-election at the forthcoming annual general meeting of the Company has a service contract or an appointment agreement with the Company which is not determinable by the Company or any of its subsidiaries within one year without payment of compensation, other than statutory compensation.

### Independent non-executive Directors

The Company has been in compliance with Rules 5.05(1) and (2), and 5.05A of the GEM Listing Rules during the Year, in which the Company had three independent non-executive Directors, representing at least one-third of the Board. Among the three independent non-executive Directors, Mr. Hon Ming Sang has the appropriate professional qualifications or accounting or related financial management expertise.

The Company has received from each of the independent non-executive Directors an annual confirmation of his/her independence pursuant to Rule 5.09 of the GEM Listing Rules and the Company considers all the independent non-executive Directors are or have remained independent.

### Nomination policy

The Board has adopted a nomination policy ("Nomination Policy"). Such policy aims to improve transparency around the criteria and procedure adopted by the Nomination Committee in selecting and recommending candidates as Directors and to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business. Selection of candidates shall be based on a range of criteria, including but not limited to, integrity and reputation, professional qualifications, skills, knowledge and experience that are relevant to the Company's business and corporate strategy, gender, age, cultural and educational background, ethnicity, and length of service. The Nomination Committee shall convene a meeting to discuss and consider the recommendation of any candidate to the Board for appointment, election or re-election as a Director by the Board or at a general meeting of the Company.

根據本公司組織章程細則第 108(a) 條，於本公司各屆股東週年大會上，當時董事人數的三分之一須輪席告退，而有關退任董事全部均符合資格並將願意重選連任。有關將於本公司應屆股東週年大會上輪值退任及（如適用）接受重選連任的董事詳情將載於適時寄發予股東的通函。概無擬於本公司應屆股東週年大會膺選連任之董事與本公司訂有服務合約或委任協議，而本公司或其任何附屬公司不能於一年內在毋須支付賠償（法定賠償除外）下終止。

### 獨立非執行董事

本公司於年內已遵守 GEM 上市規則第 5.05(1) 及 (2) 條以及第 5.05A 條。本公司已有三名獨立非執行董事，佔董事會人數不少於三分之一。於三名獨立非執行董事中，韓銘生先生擁有適當專業資格或會計或相關財政管理專業知識。

根據 GEM 上市規則第 5.09 條，本公司已獲得各獨立非執行董事之獨立性年度確認書，本公司認為全體獨立非執行董事均為或仍為獨立人士。

### 提名政策

董事會已採納提名政策（「提名政策」）。該政策旨在提高提名委員會在選擇及推薦候選人為董事時所採用的標準及程序的透明度，並確保董事會在技能、經驗及適合公司業務要求的多樣性方面保持平衡。選擇候選人須以一系列標準為基準，包括但不限於誠信及聲譽、專業資格、技能、與公司業務及公司戰略相關的知識及經驗、性別、年齡、文化及教育背景、種族及服務年限。提名委員會須召開會議，以討論及考慮董事會或本公司股東大會委任、選舉或重選任何候選人為董事的建議。

### Board diversity policy

The Board has adopted a board diversity policy ("Board Diversity Policy") in accordance with the requirements set out in the CG Code. Such policy aims to set out the approach to achieve diversity on the Board. The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. The Company endeavours to ensure that the Board has the appropriate balance of skills, experience and diversity of perspectives that are required to support the execution of its business strategy and to maximise the Board's effectiveness. Accordingly, all Board appointments shall be based on meritocracy and candidates shall be considered against objective criteria, having due regard to the benefits of diversity on the Board. Selection of candidates shall be based on a range of diversity perspectives, including but not limited to, gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision shall be based on the merit and contribution the selected candidates could bring to the Board. The Nomination Committee will monitor the implementation of the Board Diversity Policy. The Board shall review the Board Diversity Policy and its implementation and effectiveness on an annual basis to ensure the effectiveness of the Board Diversity Policy. The Nomination Committee will continue to give adequate consideration to these measurable objectives when making recommendations of candidates for appointment to the Board.

During the Year and as at the date of this annual report, the Board comprised at least (i) four female members and two male members; and (ii) three executive Directors and three independent non-executive Directors.

Taking into account that the Board has a balanced mix of skill-set, experience, and diversity which strengthens its decision-making capability and the overall effectiveness of the Company in achieving sustainable business operation and enhancing shareholder value, the Company considers that the current composition of the Board satisfies the principles set out in the Board Diversity Policy.

The Board also recognises the importance of diversity at the workforce level. As at 31 December 2024, the gender ratio of the workforce of the Group (including senior management) was 2.3:1 male to female.

### 董事會成員多元化政策

董事會已根據企業管治守則所載之規定採納董事會成員多元化政策（「董事會成員多元化政策」）。有關政策旨在載列達致董事會成員多元化的方針。本公司認同並深信董事會成員多元化有利於提升其表現質素。本公司致力確保董事會於專長、經驗和多元化觀點方面達致適當平衡，使其能執行本公司之業務策略及董事會之有效運作。因此，董事會所有委任均以用人唯才為原則，並在考慮人選時以客觀標準充分顧及董事會成員多元化的裨益。甄選人選將按一系列多元化範疇為基準，包括但不限於性別、年齡、文化及教育背景、種族、專業經驗、技能、知識及服務年限。最終決定將按經甄選人選的優點及其可為董事會提供的貢獻而作出。提名委員會將監察董事會多元化政策的實施。董事會將每年檢討董事會多元化政策及其實施與成效，以確保該董事會成員多元化政策行之有效。提名委員會將繼續就委任人選向董事會作出推薦建議時持續充分考慮該等可衡量目標。

於年內及於本年報日期，董事會包括至少 (i) 四名女性成員及兩名男性成員；及 (ii) 三名執行董事及三名獨立非執行董事。

考慮到董事會擁有均衡的技能組合、經驗及多元化，增強了其決策能力及本公司於實現可持續業務經營及提高股東價值方面的整體效率，本公司認為目前董事會的組成符合董事會多元化政策中規定的原則。

董事會亦認同員工層面多元化的重要性。於二零二四年十二月三十一日，本集團員工（包括高級管理人員）的性別比例為 2.3:1 男性對女性。

### Independent views policy

To ensure independent views and input are available to the Board, the Company has established a policy ("Independent Views Policy"), under which the independent non-executive Directors are required to, among others, bring independent judgment to bear on the Company's issues of strategy, policy, performance, accountability, resources, key appointments and standards of conduct, help review some of the Board's major decisions and the Company's performance in relation to corporate goals, monitor the Company's performance reporting, and take the lead where potential conflicts of interest arise. Further, the independent non-executive Directors must make sufficient time available to discharge their responsibilities and should not accept an invitation to serve as an independent non-executive Director on the Board unless they can devote adequate time and effort to the work involved. Independent non-executive Directors sitting on multiple boards of directors of listed companies will need to ensure that they devote sufficient time and dedicate adequate attention to each board and board committee.

Apart from regular board meetings which allow independent non-executive Directors to express their views, the Chairman meets the independent non-executive Directors without the presence of any other Director at least once a year to ensure independent views and input are available to the Board. In addition, the Company ensures that all the Directors (including the independent non-executive Directors) will have access to advice from external independent professionals, including independent legal advisors, auditors and valuers, to assist the Directors to perform their duties.

The Company is required to review the Independent Views Policy and its implementation and effectiveness on an annual basis. The Company has reviewed the Independent Views Policy and its implementation and effectiveness during the Year and considered the results of such review satisfactory.

### Dividend policy

The Board has adopted a dividend policy ("Dividend Policy"). Dividends may be paid out by way of cash or by other means that the Directors consider appropriate. Declaration and payment of any dividends would require the recommendation of the Board and will be at its discretion. In addition, any final dividends for a financial year will be subject to the approval of the Shareholders. A decision to declare or to pay any dividends in the future, and the amount of any dividends, depends on a number of factors, including the results of operations and financial condition of the Group, the payment by the Company's subsidiaries of cash dividends to the Company, and other factors the Board may deem relevant. Declaration and payment of dividends by the Company are subject to compliance with applicable laws and regulations including the laws of the Cayman Islands and the articles of association of the Company.

### 獨立意見政策

為確保可向董事會提供獨立的觀點及意見，本公司已制定一項政策（「獨立意見政策」），據此，獨立非執行董事必須（其中包括）對本公司的策略、政策、業績、問責、資源、主要委任及為標準等事宜作出獨立判斷，協助審議董事會的部分重大決策及本公司有關企業目標的表現，監督本公司的表現匯報，並在出現潛在利益衝突時發揮主導作用。此外，獨立非執行董事須有足夠的時間來履行其職責，且除非彼等能投入足夠的時間及精力來完成相關的工作，否則不應接受邀請擔任董事會的獨立非執行董事。於上市公司的多個董事會任職的獨立非執行董事需要確保彼等對各董事會及董事會委員會投入充足時間及提供足夠的精力。

除可讓獨立非執行董事發表意見的定期董事會會議外，主席至少每年一次在無任何其他董事在場的情況下會晤獨立非執行董事，以確保董事會能獲得獨立的觀點及意見。此外，本公司確保所有董事（包括獨立非執行董事）均能獲得外部獨立專業人士（包括獨立法律顧問、核數師及估值師）的建議，以協助董事履行其職責。

本公司須每年檢討獨立意見政策及其實施與成效。本公司已於本年度檢討獨立意見政策及其實施與成效，並認為有關檢討結果令人滿意。

### 股息政策

董事會已採納股息政策（「股息政策」）。股息或以現金或董事認為合適的其他方式派付。宣派及派付任何股息須由董事會酌情提出建議。此外，財政年度的任何末期股息須經股東批准。日後宣派或派付任何股息及任何股息的金額的決定將視乎多項因素而定，包括本集團的經營業績及財務狀況、本公司的附屬公司向本公司支付的現金股息以及董事會可能認為有關的其他因素。本公司股息的宣派與派付須遵守適用法律及法規，包括開曼群島法律及本公司組織章程細則。

## 企業管治報告

The Board will review the Dividend Policy from time to time and may exercise its sole and absolute discretion to update, amend and/or modify the Dividend Policy at any time as it deems fit and necessary.

There is no assurance that dividends will be declared or paid in any particular amount for any given period.

### Chairman and chief executive officer

According to code provision C.2.1 of the CG Code, the roles of the chairman and the chief executive officer of a listed issuer should be separate and should not be performed by the same individual. During the Year, the role of the Chairman was performed by Ms. Tin Yat Yu Carol (former name as Tin Yuen Sin Carol), while Ms. Liu Mung Ting acted as the Chief Executive Officer. The Chairman is to provide leadership for the Board and to ensure that the Board works effectively. The Chief Executive Officer is responsible for the day-to-day management of the Group's business. During the Year, the positions of the Chairman and the Chief Executive Officer were held by separate individuals so as to maintain an effective segregation of duties.

### Continuing professional development

According to code provision C.1.4 of the CG Code, all Directors shall participate in continuous professional development to develop and refresh their knowledge and skills to ensure their contribution to the Board remains informed and relevant.

During the Year, each of the Directors received regular updates and presentations on changes and developments to the Group's business and to the legislative and regulatory environments in which the Group operates, and was also encouraged to attend relevant training courses. During the Year, each of the Directors, i.e. Ms. Tin Yat Yu Carol (former name as Tin Yuen Sin Carol), Ms. Liu Mung Ting, Ms. Lin Ting, Mr. Hon Ming Sang, Ms. Lee Kwun Ling, May Jean, and Mr. Tang Shu Pui Simon participated in appropriate continuous professional development activities by way of attending training or reading materials relevant to the Group's business, the GEM Listing Rules or directors' duties, and provided his or her training records to the Company on a yearly basis.

### Directors' and officers' liabilities insurance and indemnity

The Company has arranged for appropriate insurance covering the liabilities in respect of any legal action against the Directors that may arise out of the corporate activities, so as to comply with the CG Code. The insurance coverage is reviewed on an annual basis.

於年內，各董事已獲得有關本集團業務以及本集團經營所在地的法律與監管環境變動及發展之定期更新資料及演示材料，本公司亦鼓勵各董事參加相關培訓課程。於年內，各董事，即田一好女士（曾用名為田琬善）、廖夢婷女士、林靈女士、韓銘生先生、李筠翎女士及鄧澍培先生，均已透過參加有關本集團業務、GEM 上市規則或董事職責的相關培訓或閱讀相關資料，參加適當的持續專業發展活動，並每年向本公司提供其培訓記錄。

### 董事及職員責任保險及彌償

本公司已作出適當保險安排，涵蓋有關針對董事之任何法律行動（可能於企業活動產生）之責任以符合企業管治守則。保險涵蓋範圍每年檢討一次。

### 1. Audit Committee

The Company established an audit committee (“Audit Committee”) of the Company on 10 September 2013 with written terms of reference posted on the websites of GEM and of the Company. Such written terms of reference were revised and adopted by the Board on 29 December 2015 in accordance with the revised CG Code taking effect on 1 January 2016. The primary duties of the Audit Committee are, among other matters, to review the Company’s financial information and to monitor the Company’s financial reporting system, risk management and internal control systems.

From 1 January 2024 up to the date of this annual report, the Audit Committee comprised three independent non-executive Directors, namely Mr. Hon Ming Sang, Ms. Lee Kwun Ling, May Jean and Mr. Tang Shu Pui Simon. During the Year and up to the date of this annual report, the Audit Committee was chaired by Mr. Hon Ming Sang.

The Audit Committee reviewed the accounting standards and practices adopted by the Group and discussed with the management about the internal control and financial reporting matters for the Year. During the Year, the Audit Committee also reviewed the effectiveness of the Group’s risk management and internal control systems and internal audit function. The Group’s half-yearly and annual results for the Year have also been reviewed by the Audit Committee, which was of the opinion that the preparation of such results complied with the applicable accounting standards and that adequate disclosures had been made.

During the Year, 6 Audit Committee meetings were held and the details of attendance of each Audit Committee member are set out in the section headed “Attendance of Directors at Meetings” on page 40 of this annual report.

### 2. Remuneration Committee

The Company established the Remuneration Committee on 10 September 2013 with written terms of reference in accordance with the CG Code which are posted on the websites of GEM and of the Company. Such written terms of reference were revised and adopted by the Board on 15 December 2022 in accordance with the revised CG Code taking effect on 1 January 2023. The primary duties of the Remuneration Committee are, among other matters, to review and make recommendations to the Board on the terms of remuneration packages of the executive Directors and senior management of the Company and on the establishment of a formal and transparent procedure for developing the remuneration policy.

- to monitor the status of the compliance and corporate governance system of the Group; and
- to investigate compliance problems of the Group and take appropriate measures when one arises (it may instruct the relevant department(s) to deal with the problem depending on its nature).

During the Year, the members of the Compliance Committee monitored the status of the compliance and corporate governance system of the Group from time to time, and the Compliance Committee was of the view that there was no compliance issue of the Group which required the Compliance Committee to resolve by way of a meeting. Therefore, no meeting of the Compliance Committee was held during the Year.

### ACCOUNTABILITY AND AUDIT

#### Directors' and auditor's responsibilities for the consolidated financial statements

The Directors acknowledge their responsibility for preparing the consolidated financial statements of the Group for each financial period to give a true and fair view of the state of affairs of the Group and of the results and cash flows for that period. In preparing the consolidated financial statements for the Year, the Board has selected suitable accounting policies and applied them consistently, made judgments and estimates that are prudent, fair and reasonable and prepared the consolidated financial statements on a going concern basis. The Directors are responsible for taking all reasonable and necessary steps to safeguard the assets of the Group and to prevent and detect fraud and other irregularities. The Directors continue to adopt the going concern approach in preparing the consolidated financial statements of the Group and are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

The reporting responsibilities of the Company's external auditor, RSM Hong Kong, are set out in the section headed "Independent Auditor's Report" on pages 63 to 70 of this annual report.

#### Auditor's Remuneration

During the Year, the remuneration paid or payable to the Group's external auditor for the audit and non-audit services provided amounted to HK\$1,030,000 and HK\$100,000 respectively. The non-audit services comprised fees for the agreed upon procedures services.

本公司外部核數師羅申美會計師事務所的申報責任載於本年報第 63 頁至 70 頁「獨立核數師報告」一節。

#### 核數師之酬金

於年內，就本集團外部核數師所提供之審核及非審核服務已付或應付予其之酬金分別為 1,030,000 港元及 100,000 港元。非審核服務包括協定程序服務的費用。

## CORPORATE GOVERNANCE FUNCTIONS

The Board has not established a corporate governance committee. According to code provision A.2.1 of the CG Code, the Board is responsible for performing the corporate governance duties of the Company. The Board shall have the following duties and responsibilities for performing the corporate governance duties of the Company:

- to develop and review the policies and practices on corporate governance of the Group and make recommendations;
- to review and monitor the training and continuous professional development of Directors and senior management;
- to review and monitor the Group's policies and practices on compliance with legal and regulatory requirements;
- to develop, review and monitor the code of conduct and compliance manual (if any) applicable to Directors and employees; and
- to review the Company's compliance with the CG Code and disclosure in the corporate governance report of the Company.

The Board reviewed the Company's policies and practices on corporate governance and compliance with the CG Code, reviewed and monitored the training and continuous professional development of Directors and senior management, and the Group's policies and practices on compliance with legal and regulatory requirements during the Year as well as the disclosure in this corporate governance report.

## RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges its responsibility for the effectiveness of the Group's risk management and internal control systems on an ongoing basis. The main features of the risk management and internal control systems of the Group include the identification, assessment and evaluation of risks, the development and continuous updating of mitigation measures, and the ongoing review of internal control procedures to ensure their effectiveness. The Group has also established an organisational structure in such control systems, clearly defining the power and obligations of each department in the Group, in order to protect the Group's assets against improper use and ensure compliance with rules and regulations. Such risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatement or loss.

## 風險管理及內部監控

董事會確認其持續維持本集團風險管理及內部監控系統有效性之責任。本集團風險管理及內部監控系統的主要特點包括風險識別、評估及評價、緩解措施的制定及持續更新，以及持續檢討內部監控程序以確保其有效性。本集團亦已在此監控系統中建立組織架構，明確界定本集團各部門的權力及責任，以保護本集團資產免遭不當使用及確保遵守規則及規例。該風險管理及內部監控系統旨在管理而非消除未能實現業務目標之風險，並僅可就避免重大錯誤陳述或損失提供合理但並非絕對之保證。

## 企業管治報告

The Company has an internal control manual containing policies on information disclosure which is applicable to all employees of the Company and regularly reminds Directors and employees to properly comply with relevant policies on inside information while notifying the Directors (who are also the senior management of the Group) and employees the latest guidance announced by the regulatory body on disclosure of such information from time to time to keep all of them abreast of the latest information.

### Process used to identify, evaluate and manage significant risks

The Group's risk management process involves the identification, evaluation, response, monitoring and reporting of risks. After risks that may potentially affect the Group's business and operations are identified by the management of the Company, the Board will perform risk assessment by prioritising the identified risks to determine key risks exposed to the Group and discuss measures to mitigate such key risks. Besides, existing risk mitigation measures are subject to regular monitoring by the management of the Company, which will review the Group's risk management strategies, and report such results and make appropriate suggestions to the Board.

The Board has in place an internal audit function within the Group as required under code provision D.2.5 of the CG code. The Group conducts review of the risk management and internal control systems on annual basis. During the Year, to strengthen the risk management and internal control of the Group, the Company has engaged an independent professional adviser ("Internal Control Adviser") to perform independent appraisal of the adequacy and effectiveness of certain subsidiary's risk management and internal control system for the Year. The scope of review for the Year included revenue cycle as well as payroll cycle of a principal operating subsidiary. The Internal Control Adviser has reported major findings and areas for improvement to the Audit Committee. All recommendations from the Internal Control Adviser would be followed up closely to ensure that they are implemented within a reasonable period of time. The Board is of the opinion that the Group's risk management and internal control systems are effective and adequate and that nothing has come to its attention to cause the Board to believe the Group's risk management and internal control systems are inadequate. The Board has also considered the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function.

The Group believes that good corporate governance practices are very important for maintaining and promoting investor confidence and for the sustainable growth of the Group. The Group has therefore made continued efforts to uplift the quality of its corporate governance.

董事會已根據企業管治守則的守則條文第D.2.5條於本集團內設立內部審核職能。本集團按年對風險管理及內部監控系統進行檢討。於年內，為加強本集團的風險管理及內部監控，本公司已委聘一名獨立專業顧問（「內部監控顧問」）對若干附屬公司於本年度的風險管理及內部監控系統的充足性及有效性展開獨立評估。本年度檢討的範圍包括一間主要營運附屬公司的收益流程以及薪酬流程。內部監控顧問已向審核委員會報告主要調查結果及改善範圍。內部監控顧問的所有推薦建議會予以密切跟進，確保於合理的時間範圍內實施。董事會認為本集團的風險管理及內部監控系統屬充足有效，及董事會並無發現令其認為本集團的風險管理及內部監控屬不充足的事項。董事會亦已考慮本公司會計及財務申報職能方面之資源、員工資歷及經驗，以及員工接受之培訓課程及有關預算是否足夠。

本集團相信良好的企業管治常規對於維持及促進投資者信心及自身的可持續發展至關重要。因此，本集團一直致力於提升其企業管治水準。

## COMMUNICATIONS WITH SHAREHOLDERS AND INVESTORS

The Company has adopted a shareholders' communication policy with objective of ensuring that the Shareholders, the potential investors and the investment community (collectively, "Investors") are provided with ready, equal and timely access to balanced and understandable information about the Group, which will enable the Shareholders and the Investors to make the informed investment decisions.

In line with the Company's shareholders' communication policy, the Company communicates with the Shareholders and Investors of the Company mainly in the following ways:

- (a) the holding of annual general meetings and extraordinary general meetings, if any, which may be convened for specific purposes and provide opportunities for the Shareholders and the Investors to communicate directly with the Board;
- (b) the publication of quarterly, interim and annual reports, circulars, announcements and notices of Shareholders' meetings as required under the GEM Listing Rules and/or press releases of the Company providing updated information of the Group; and
- (c) the provision of the latest information of the Group on the websites of GEM and of the Company.

Pursuant to article 65 of the articles of association of the Company, an annual general meeting of the Company shall be called by at least 21 days' notice in writing and all other meetings (including an extraordinary general meeting) shall be called by at least 14 days' notice in writing.

The Company has reviewed the implementation and effectiveness of its shareholders' communication policy during the Year. The Company convened one shareholders' meeting held on 14 June 2024 ("2024 AGM"), which allowed the Shareholders to communicate directly with the Directors at the 2024 AGM. In addition, information relating to the Company, including interim and annual reports, announcements, circulars and poll results of the 2024 AGM, as well as notice of the 2024 AGM have been published or sent to the Shareholders in accordance with the requirements under the GEM Listing Rules during the Year, which allow the Shareholders and the Investors to have ready, equal and timely access to the information of the Group. In view of the above, the Company considered its shareholders' communication policy to be effective.

#### Convening an extraordinary general meeting by Shareholders

Pursuant to article 64 of the articles of association of the Company, any one or more Shareholders holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings of the Company shall at all times have the right, by requisition in writing to the Board or the Company Secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within two months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitioner(s) himself/herself/themselves may do so in the same manner, and all reasonable expenses incurred by the requisitioner(s) as a result of the failure of the Board shall be reimbursed to the requisitioner(s) by the Company.

#### Procedures for sending enquiries and proposals to the Board

Shareholders may send their enquiries and/or put forward proposals to the Company, for the attention of the Board or the Company Secretary, by posting the same to Unit 708, 7th Floor, Capital Centre, 151 Gloucester Road, Wanchai, Hong Kong.

For the avoidance of doubt, Shareholders must deposit and send the original duly signed written requisition, notice or statement, or enquiry (as the case may be) to the above address and provide their full name, contact details and identification in order to give effect thereto. Shareholders' information may be disclosed as required by law.

### COMPANY SECRETARY

Mr. Yu Kwan Nam Gabriel has been appointed by the Board as the Company Secretary and undertook not less than 15 hours of relevant professional training to update his skills and knowledge during the Year.

### CONSTITUTIONAL DOCUMENTS

During the Year, the memorandum and articles of association of the Company were amended in line with the then latest regulatory requirements, including the amendments made to the GEM Listing Rules. Details of the amendments are disclosed in the Company's announcement and circular dated 17 May 2024 and 21 May 2024, respectively. The amended and restated memorandum and articles of association of the Company were adopted by the Company pursuant to the shareholders' resolution passed on 14 June 2024 and are available on the respective websites of the Stock Exchange and the Company.

### EQUITY-LINKED AGREEMENT

During the Year, the Group did not enter into any equity-linked agreement.

### ISSUE OF SHARES

On 5 December 2023, the Board proposed to (i) increase the existing authorised share capital of the Company from HK\$10,000,000 divided into 200,000,000 ordinary shares with a par value of HK\$0.05 each to HK\$100,000,000 divided into 2,000,000,000 shares by creating additional 1,800,000,000 unissued shares (“Increase in Authorised Share Capital”); and (ii) raise approximately HK\$27.98 million by issuing up to 378,174,702 new ordinary shares to the qualifying Shareholders on the basis of three (3) rights shares (“Rights Shares”) for every one (1) share in issue at the subscription price of HK\$0.074 per share (“Rights Issue”).

The Company also entered into a placing agreement with a placing agent, pursuant to which the placing agent has conditionally agreed to procure placees, on a best effort basis, to subscribe for the unsubscribed Rights Shares and unsold Rights Shares as part of the compensatory arrangements (“Placing”).

An extraordinary general meeting was held by the Company on 16 January 2024, and the above proposed events were approved by the shareholders of the Company. Upon the completion of the Rights Issue and the Placing, the number of shares of the Company in issue was increased by 378,174,702, resulting in a credit to share capital and share premium by HK\$18,909,000 and HK\$7,602,000, respectively after netting of the related cost of approximately HK\$1,474,000. Details of the Increase in Authorised Share Capital, the Rights Issue and the Placing are disclosed in the Company’s announcements dated 5 December 2023, 18 December 2023, 19 December 2023, 16 January 2024, 16 February 2024 and 27 February 2024, the Company’s circular dated 28 December 2023 and the Company’s prospectus dated 29 January 2024.

The Directors are of the view that the Rights Issue is in the best interests of the Company and the Shareholders as a whole and that the Rights Issue is an appropriate fundraising method to strengthen the capital base of the Company, which in turn will support the Company’s continuing development and business growth, while allowing the qualifying Shareholders to maintain their proportional shareholdings in the Company.

The Company intends to apply the net proceeds from the Rights Issue (i) to support the research and development centre in Shenzhen Futian District, PRC, instead of Qianhai, PRC as stated in the Company's prospectus dated 29 January 2024 due to better terms of the tenancy of premises in such location secured by the Group ("Shenzhen R&D Center"), (ii) to expand the customer support, product development, and research and compliance teams in Hong Kong, and support these teams with relevant equipment and infrastructure, (iii) to develop new IT system products to explore business opportunities in other geographical locations, such as Southeast Asia, and (iv) as general working capital of the Group. For further details of the Rights Issue, please refer to the announcement of the Company dated 5 December 2023 and the Company's circular dated 28 December 2023 and the Company's prospectus dated 29 January 2024.

The Rights Issue was completed on 28 February 2024. As such, 378,174,702 ordinary shares with par value of HK\$0.05 each (with aggregate nominal value of HK\$18,908,735.1), were issued and allotted under the Rights Issue with net proceeds (after deduction of expenses) of approximately HK\$26.51 million raised. The issue price and net price per Rights Share were HK\$0.074 and approximately HK\$0.069 respectively. The closing price of the share of the Company as quoted on the Stock Exchange on 5 December 2023 was HK\$0.103 per share. Reference is made to the announcement of the Company dated 27 February 2024.

As at 31 December 2024, the Group had loan and interest receivables from customers from money lending business at gross amounting to approximately HK\$69,501,000 and HK\$2,316,000 respectively. Provision for impairment loss on loan and interest receivables were approximately HK\$33,824,000 and HK\$1,176,000 respectively as at 31 December 2024.

Management assessed the provision for impairment on loan and interest receivables and consideration receivable based on the estimation of expected credit losses ("ECL") under a "three-stage" model. In developing the loss allowance for loan and interest receivables, management uses judgement in making the assumptions about the probability of default and loss given default with reference to the historical delinquency ratio of loan portfolio, credit rating of customers and current and forward-looking information on macroeconomic factors.

### 1. GENERAL INFORMATION

Finsoft Financial Investment Holdings Limited (“Company”) was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law of the Cayman Islands. The address of its registered office is Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of its principal place of business in Hong Kong is Unit 708, 7th Floor, Capital Centre, 151 Gloucester Road, Wanchai, Hong Kong. The Company’s shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The principal activity of the Company is investment holding. The principal activities of its subsidiaries are set out in note 23 to the consolidated financial statements.

### 2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with all applicable HKFRS Accounting Standards issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”). HKFRS Accounting Standards comprise Hong Kong Financial Reporting Standards (“HKFRS”); Hong Kong Accounting Standards (“HKAS”); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on GEM of the Stock Exchange and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622).

The HKICPA has issued certain new and revised HKFRS Accounting Standards that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

### 1. 一般資料

### 4. MATERIAL ACCOUNTING POLICY INFORMATION

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. investment properties and certain financial instruments that are measured at fair value).

The preparation of consolidated financial statements in conformity with HKFRS Accounting Standards requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in note 5.

The material accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### (a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any accumulated foreign currency translation reserve relating to that subsidiary.

### 4. 重大會計政策資料

#### (a) 綜合賬目

綜合財務報表包括本公司及其附屬公司截至十二月三十一日止之財務報表。附屬公司指本集團對其擁有控制權之實體。當本集團獲得或享有參與實體所得之浮動回報，且有能透過其對實體之權力影響該等回報時，則本集團可控制該實體。當本集團之現有權力賦予其目前能掌控有關業務（即顯著影響實體回報之業務）時，則本集團對該實體擁有權力。

在評估控制權時，本集團會考慮其潛在投票權以及其他人士所持有之潛在投票權。僅在持有人能實際行使該權力之情況下，方被視為有潛在投票權。

附屬公司在控制權轉移至本集團之日起綜合入賬。附屬公司在控制權終止之日起停止綜合入賬。

因出售附屬公司而導致失去控制權之盈虧為 (i) 出售代價之公平價值加任何保留於該附屬公司之投資之公平價值及 (ii) 本公司應佔該附屬公司資產淨值加任何剩餘商譽及任何有關該附屬公司之累計匯兌儲備兩者間之差額。

#### (a) Consolidation (Continued)

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

#### (b) Separate financial statements

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment losses, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale). Cost includes direct attributable costs of investments. The results of subsidiaries are accounted for by the Company on the basis of dividend received or receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("functional currency"). The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the Company's functional and presentation currency.

##### (ii) *Transactions and balances in each entity's financial statements*

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the entity initially recognises such non-monetary assets or liabilities. Non-monetary items that are measured at fair value in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

##### (iii) Translation on consolidation

The results and financial position of all foreign operations (none of which has the currency of hyperinflationary economy) that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- Income and expenses are translated at average exchange rates for the period (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- All resulting exchange differences are recognised in other comprehensive income and accumulated in the foreign currency translation reserve.

On consolidation, exchange differences arising from the translation of monetary items that form part of the net investment in foreign entities are recognised in other comprehensive income and accumulated in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are reclassified to consolidated profit or loss as part of the gain or loss on disposal.

#### (d) Property, plant and equipment

Property, plant and equipment are held for use in the production or supply of goods or services, or for administrative purposes (other than properties under construction as described below). Property, plant and equipment are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates are as follows:

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period with the effect of any changes in estimate accounted for on a prospective basis.

Construction in progress represents buildings under construction and plant and equipment pending installation, and is stated at cost less impairment losses. Depreciation begins when the relevant assets are available for use.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

#### (e) Investment properties

Investment properties are land and/or buildings which are owned or held under a leasehold interest to earn rentals and/or for capital appreciation. These include land held for a currently undetermined future use and property that is being constructed or developed for future use as investment property.

Investment property are stated at fair value, unless they are still in the course of construction or development at the end of the reporting period and their fair value cannot be reliably measured at that time.

Gains or losses arising from changes in the fair value of investment properties are recognised in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is withdrawn from use. Any gain or loss on disposal of an investment property is the difference between the net sales proceeds and the carrying amount of the property, and is recognised in profit or loss. Rental income from investment properties is accounted for as described in note 4(p).

#### (f) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

##### *The Group as a lessee*

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

#### (e) 投資物業

投資物業指為賺取租金收入及／或為資本增值而以租賃權益擁有或持有之土地及／或樓宇，包括目前未確定未來用途之持有土地及正在興建或發展作為投資物業供日後使用之物業。

除於報告期末仍在興建或發展中的物業而其公平價值並不能可靠地估算外，投資物業按公平價值列賬。

投資物業公平價值變動產生之收益或虧損，於產生期間之損益中確認。

投資物業於出售或投資物業不再使用時終止確認。出售投資物業的任何收益或虧損為銷售所得款項淨額與該物業賬面值的差額，並於損益中確認。投資物業的租金收入按附註 4(p) 所述入賬。

#### (f) 租賃

於合約成立時，本集團會評估合約是否為租賃或包含租賃。倘合約賦予在一段時間內控制已識別資產使用的權利以換取代價，則合約為租賃或包含租賃。倘客戶有權主導已識別資產之用途及從該用途中獲得絕大部份經濟收益，則控制權已轉移。

##### *本集團作為承租人*

倘合約包含租賃部分及非租賃部分，本集團已選擇不區分非租賃部分，並就所有租賃將各租賃部分及任何相關非租賃部分作為單一租賃部分入賬。

於租賃開始日期，本集團確認使用權資產及租賃負債(租賃期為 12 個月或以下的短期租賃以及低價值資產租賃除外)。當本集團就低價值資產訂立租賃時，本集團按逐項租賃情況決定是否將租賃資本化。而與該等不作資本化租賃相關的租賃付款於租賃期內按系統基準確認為開支。

###### *The Group as a lessee (Continued)*

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. Lease payments to be made under reasonably certain extension options are also included in the measurement of the lease liability. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method.

To determine the incremental borrowing rate, the Group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received;
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases held by the Company and iAsia Online Systems Limited, which do not have recent third-party financing; and
- makes adjustments specific to the lease, e.g. term, country, currency and security.

If a readily observable amortising loan rate is available to the individual lessee (through recent financing or market data) which has a similar payment profile to the lease, then the group entities use that rate as a starting point to determine the incremental borrowing rate.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

倘租賃已資本化，租賃負債初步按租期應付租賃款項現值確認，並按租賃中所隱含之利率貼現，倘該利率不易釐定，則使用相關增量借款利率。計量租賃負債包括本集團認為合理肯定可延續之租賃付款。初步確認後，按攤銷成本計量租賃負債及使用實際利率法計量利息開支。

為釐定增量借款利率，本集團：

- 盡可能使用個別承租人最近獲得的第三方融資作為起點，並作出調整，以反映自收到第三方融資起的融資狀況變化；
- 使用累積方法，從就本公司及亞洲網上系統有限公司（一般近期並無第三方融資）持有租賃的信用風險作出調整的無風險利率開始；及
- 作出租賃特定（如期限、國家、貨幣及擔保）的調整。

倘個別承租人（通過近期的融資或市場數據）取得支付情況與租賃相近的易於觀察的攤銷貸款利率，則集團實體以該利率作為釐定增量借款利率的起步點。

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

When the Group obtains ownership of the underlying leased assets at the end of the lease term, upon exercising purchase options, the carrying amount of the relevant right-of-use asset is transferred to property, plant and equipment.

Refundable rental deposits paid are accounted under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group's estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract ("lease modification") that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification.

本集團合理確定於租賃期完結時可獲得相關租賃資產擁有權之使用權資產從開始日期至可使用年期完結計算折舊。除此之外，使用權資產按其估計可使用年期及租賃期較短者，以直線法計算折舊。

當本集團於租賃期結束時獲得相關租賃資產的所有權時，於行使購買權後，相關使用權資產的賬面值轉撥至物業、廠房及設備。

已付可退還租賃按金根據香港財務報告準則第9號入賬，並初步按公平價值計量。於初步確認時對公平價值的調整被視為額外租賃付款，並計入使用權資產成本。

倘指數或利率變動引致未來租賃付款變動，或本集團根據剩餘價值擔保預期應付款項之估計有變，或當重新評估本集團是否將合理確定行使購買、延期或終止選擇權而產生變動，則會重新計量租賃負債。當租賃負債以此方式重新計量，則就使用權資產之賬面值作出相應調整，或倘使用權資產之賬面值減至零，則於損益入賬。

當租賃範疇發生變化或租賃合約原先並無規定的租賃代價發生變化(「租賃修改」)，且未作為單獨的租賃入賬時，則亦要對租賃負債進行重新計量。在此情況，租賃負債根據經修訂的租賃付款和租賃期，使用經修訂的貼現率在修改生效日重新計量。

##### *The Group as a lessor*

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

#### (g) Club membership

Club membership with indefinite useful life is stated at cost less any impairment losses. Impairment is reviewed annually or when there is any indication that the club membership has suffered an impairment loss.

#### (h) Contract liabilities

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

#### (i) Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at FVTPL) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

倘本集團擔任出租人，則於租賃開始時釐定各租賃是否為融資租賃或經營租賃。倘租賃將相關資產擁有權附帶的絕大部分風險及回報轉移至承租人，則分類為融資租賃。倘不屬於以上情況，則租賃分類為經營租賃。

#### (g) 會所會籍

擁有無限可使用年期的會所會籍按成本減任何減值虧損列賬。會所會籍每年或當有跡象顯示出現減值虧損時進行減值檢討。

#### (h) 合約負債

當客戶在本集團確認相關收益前支付代價，則確認合約負債。倘本集團在確認相關收益前有無條件收取代價之權利，亦會確認合約負債。在該等情況下，會確認相應之應收款項。

對於與客戶簽訂之單項合約，將呈報合約淨資產或合約淨負債。對多份合約而言，非關聯合約之合約資產及合約負債不呈報淨額。

#### (i) 確認及終止確認金融工具

當本集團實體成為工具合約條文的訂約方時，金融資產及金融負債於綜合財務狀況表確認。

金融資產及金融負債初始按公平價值計量。收購或發行金融資產及金融負債(按公平價值計入損益的金融資產及金融負債除外)直接應佔的交易成本均於初始確認時加入至或扣除自金融資產或金融負債的公平價值(如適用)。收購按公平價值計入損益的金融資產或金融負債直接應佔的交易成本即時於損益確認。

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

#### (j) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

###### *Equity investments*

An investment in equity securities is classified as FVTPL unless the equity investment is not held for trading purposes and on initial recognition of the investment the Group makes an election to designate the investment at FVTOCI (non-recycling) such that subsequent changes in fair value are recognised in other comprehensive income. Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (non-recycling) is transferred to retained earnings. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVTPL or FVTOCI, are recognised in profit or loss as other income.

##### (k) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method less allowance for credit losses.

##### (l) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for ECL.

股本證券投資乃歸類為按公平價值計入損益，除非該股本投資並非持作買賣用途且投資於初始確認時，本集團選擇指定投資按公平價值計入其他全面收入(不可劃轉)，以使其後的公平價值變動於其他全面收入確認。該等選擇乃按逐項工具作出，但僅會在發行人認為投資符合股本的定義的情況下方會作出有關選擇。作出有關選擇後，於其他全面收入內累計的金額會保留於公平價值儲備內(不可劃轉)，直至完成出售投資為止。於出售時，於公平價值儲備內累計的金額(不可劃轉)會轉入保留盈利，而不會透過損益劃轉。股本證券投資的股息，無論是否歸類為按公平價值計入損益或按公平價值計入其他全面收入，均於損益內確認為其他收入。

##### (k) 貿易及其他應收款項

應收款項於本集團有無條件權利收取代價時確認。倘代價僅隨時間推移即會成為到期應付，則收取代價的權利為無條件。倘於本集團擁有無條件權利收取代價前確認收益，金額則呈列為合約資產。

貿易應收款項初始以無條件的代價款額確認，惟倘其包含重大融資成份則除外，在此情況下則按公平價值確認。本集團持有目的為收取合約現金流量的貿易應收款項，因此其後使用實際利率法以攤銷成本減信貸虧損撥備計量。

##### (l) 現金及現金等價物

現金及現金等價物包括銀行現金及手頭現金、存放於銀行及其他金融機構的活期存款，以及可隨時兌換為已知數額的現金、涉及非重大價值變動風險並於收購日期起三個月內到期的短期高流通性投資。現金及現金等價物會就預期信貸虧損進行評估。

#### (m) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRS Accounting Standards. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

#### (n) Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

#### (o) Equity instruments

An equity instrument is any contract that evidence a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

#### (p) Revenue and other income

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Revenue from provision of software maintenance, hosting and related services and outsourcing services is recognised over the contracted period on a straight-line basis because the customer simultaneously receives and consumes the benefits provided by the Group as the group performs. Advances are normally required before rendering the services.

Software licensing service income from leasing the software products to its customers is recognised as a performance obligation satisfied over time when the related services are rendered. The nature of the Group's performance obligation in granting a license is considered to be a right to access the Group's intellectual property.

#### (m) 金融負債及股本工具

金融負債及股本工具乃根據所訂立合約安排的內容及香港財務報告準則會計準則項下金融負債及股本工具的定义分類。下文載列就特定金融負債及股本工具採納的會計政策。

#### (n) 貿易及其他應付款項

貿易及其他應付款項初步按其公平價值確認，其後採用實際利率法按攤銷成本計量，除非貼現影響甚微，而於此情況下，則以成本列賬。

#### (o) 股本工具

股本工具為可證明實體於扣除其所有負債後於資產中擁有的剩餘權益的任何合約。本公司所發行之股本工具按已收所得款項扣除直接發行成本入賬。

#### (p) 收益及其他收入

收益會在產品或服務控制權轉移至顧客時，按本集團預期可享有之承諾代價金額（並不包括代表第三方收取的金額）予以確認。收益不包括增值稅或其他營業稅，但已扣除任何貿易折扣。

提供軟件保養、伺服器寄存及相關服務及外包服務的收益乃於合約期內以直線法確認，原因為在本集團履約時客戶同時接收並消耗本集團提供的利益。於提供服務之前通常會要求預付款項。

向客戶租賃軟件產品獲得的軟件特許服務收入於提供相關服務時確認為隨時間達成的履約責任。本集團授予特許權的履約責任性質被認為獲取本集團知識產權的權利。

#### (p) Revenue and other income (Continued)

Payment for services is not due from the customer until the services are complete and therefore a contract asset is recognised over the period in which the services are performed representing the entity's right to consideration for the services performed to date.

Revenue from sales of merchandise, after deduction of any discounts, is recognised at a point in time when control of the products has transferred, being when the products are delivered to the customer, the customer has accepted the products, the collection of the related consideration is probable and there is no unfulfilled obligation that could affect the customer's acceptance of the products. A receivable is recognised by the Group when goods are delivered to the customers as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due.

Revenue from sales of technology software systems, and provision of system customisation and network support services, after deduction of any discounts, is recognised at a point in time on completion of the customisation and network support work which generally coincides with the time when the customised software and network support work is accepted by the customer. A receivable is recognised by the Group when the technology software systems being delivered and/or customisation and network support work are completed at customers' location as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due.

Interest income is recognised as it accrues using the effective interest method. For financial assets measured at amortised cost or FVTOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

服務付款直至服務完成時方會到期支付，因此合約資產於提供服務的期間確認，表示實體迄今就所轉讓服務收取代價的權利。

銷售商品的收益(經扣除任何折扣)於產品控制權轉移的時間點確認，即為產品已交付予客戶、客戶已接受產品、相關代價很可能可收取且並無可能影響客戶接受產品的未履行責任時。當貨品交付予客戶時，本集團確認應收款項，原因為此代表收取代價之權利成為無條件的一個時間點，於款項到期前只須待時間過去。

來自銷售技術軟件系統以及提供系統訂製及網絡支援服務的收益(經扣除任何折扣)按訂製及網絡支援工作的完成時間(一般與客戶接納訂製軟件及網絡支援工作的時間一致)的時間點確認。當技術軟件系統交付及/或訂製及網絡支援工作於客戶所在地完成時，本集團確認應收款項，原因為此代表收取代價之權利成為無條件的一個時間點，於款項到期前只須待時間過去。

利息收入於應計時採用實際利率法確認。就按攤銷成本計量或按公平價值計入其他全面收入(可劃轉)且並無出現信貸減值之金融資產而言，資產賬面總值適用實際利率。就出現信貸減值之金融資產而言，資產之攤銷成本(即扣除虧損撥備之賬面總值)適用實際利率。

#### (p) Revenue and other income (Continued)

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Variable lease payments that do not depend on an index or a rate are recognised as income in the accounting period in which they are earned.

#### (q) Employee benefits

##### (i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

##### (ii) Pension obligations

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to profit or loss represents contributions payable by the Group to the funds.

##### (iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognises restructuring costs and involves the payment of termination benefits.

#### (r) Borrowing costs

All borrowing costs are recognised in profit or loss in the period in which they are incurred.

除非有更具代表性之基準衡量從租賃資產獲取利益之模式，經營租賃項下之應收租金收入按租期所涵蓋之期間以等額分期於損益確認。獲授之租賃激勵措施均在損益中確認為淨租賃付款應收款項總額之組成部分。不取決於指數或利率之可變租賃付款乃以賺取有關付款之會計期間確認為收入。

#### (q) 僱員福利

##### (i) 僱員假期

僱員年假及長期服務假於賦予僱員時確認。已就僱員因截至呈報期末所提供服務而享有之年假及長期服務假之估計負債作出撥備。

僱員病假及產假於休假時方始確認。

##### (ii) 退休金承擔

本集團向定額供款退休計劃作出供款，所有僱員均可參與該計劃。供款由本集團及僱員按僱員基本薪金之百分比作出。自損益扣除之退休福利計劃成本指本集團應向有關基金支付之供款。

##### (iii) 合約終止補償

合約終止補償於當本集團不再可撤銷該等福利，或當本集團確認重組成本並涉及支付合約終止補償(以較早者為準)時確認。

#### (r) 借貸成本

所有借貸成本於其產生期間在損益中確認。

#### (s) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit and at the time of transaction does not give rise to equal taxable and deductible temporary differences.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, associates and a joint venture, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

#### (s) 稅項

所得稅指即期稅項與遞延稅項之總額。

即期應付的稅項以年內應課稅溢利計算。應課稅溢利與損益中確認的溢利不同，乃由於存在於其他年度內屬應課稅或可抵扣收入或開支項目及從不課稅或不可抵扣的項目所致。本集團即期稅項負債按報告期末已制定或實質已制定的稅率計算。

遞延稅項按照綜合財務報表資產及負債的賬面值與計算應課稅溢利時所用相應稅基之間的暫時差額確認。遞延稅項負債通常按全部應課稅暫時差額確認。遞延稅項資產一般於可能出現可利用可抵扣暫時差額抵銷應課稅溢利時就全部可抵扣暫時差額確認。倘暫時差額來自商譽或交易中其他資產及負債的初步確認(業務合併除外)，且該交易既不影響應課稅溢利，亦不影響會計溢利及於交易時並不產生相等的應課稅及可抵扣暫時差額，則該等資產及負債不予以確認。

遞延稅項負債乃就於附屬公司、聯營公司及合營公司之投資而引致的應課稅暫時差額確認，除非本集團能夠控制該暫時差額的撥回及該暫時差額在可見將來不大可能撥回。

遞延稅項資產的賬面值在各報告期末進行審閱，並在不再可能有充足應課稅溢利可供收回所有或部分資產情況下扣減。

#### (s) Taxation (Continued)

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model of the Group whose business objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale. If the presumption is rebutted, deferred tax for such investment properties are measured based on the expected manner as to how the properties will be recovered.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis, or to realise the asset and settle the liability simultaneously.

#### (s) 稅項(續)

遞延稅項乃按預期於負債清償或資產變現期間適用的稅率計算，有關稅率為於報告期末前已制定或實質已制定的稅率。遞延稅項於損益中確認，惟倘遞延稅項與其他全面收入或直接在權益中確認的項目有關則除外，在此情況下遞延稅項亦會於其他全面收入或直接於權益中確認。

遞延稅項資產及負債的計量反映本集團預期在報告期末收回或清償其資產及負債的賬面值的方式所導致的稅務後果。

就計量投資物業的遞延稅項而言，使用公平價值模式計量之投資物業賬面值獲假定為可透過出售全數收回，除非推定被推翻。當有關投資物業為可折舊及以隨時間耗盡大體上所有包含在投資物業內的經濟得益為商業目的，而不是以出售方式之商業模式持有，推定則可被推翻。如果推定被推翻，該投資物業的遞延稅項根據該物業將被收回的預計方式計量。

遞延稅項資產及負債在具合法執行權利以即期稅項資產抵銷即期稅項負債，以及其與同一課稅機關徵收之所得稅有關，而本集團計劃以淨額基準處理其即期稅項資產及負債時或同時變現資產及結算負債，方予以抵銷。

##### (t) Impairment of non-financial assets

Intangible assets that have an indefinite life or that are not yet available for use are reviewed for impairment annually and whenever events or changes in circumstances indicate the carrying amount may not be recoverable.

The carrying amounts of non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the cash-generating unit to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the cash-generating unit.

Value in use is the present value of the estimated future cash flows of the asset/cash-generating unit. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/cash-generating unit whose impairment is being measured.

Impairment losses for cash-generating units are allocated pro rata amongst the assets of the cash-generating unit. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

##### (u) Impairment of financial assets

The Group recognises a loss allowance for ECL on trade and other receivables, loan and interest receivables, consideration receivable and bank and cash balances. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade receivables. The ECL on these financial assets are estimated using a provision matrix based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date, including time value of money where appropriate.

##### (t) 非金融資產減值

擁有無限年期或尚未可供使用之無形資產會每年進行減值檢討，並且當任何事件發生或情況改變顯示其賬面值可能無法收回時，亦會進行減值檢討。

非金融資產之賬面值於各報告日期檢討是否出現減值跡象，倘資產已減值，則作為開支透過綜合損益表撇減至其估計可收回金額。可收回金額就個別資產釐定，惟倘資產並無產生大部分獨立於其他資產或資產組合之現金流入，則可收回金額就資產所屬之現金產生單位釐定。可收回金額按個別資產或現金產生單位之使用價值與其公平價值減出售成本(以較高者為準)計算。

使用價值為資產／現金產生單位估計未來現金流量之現值。現值按反映貨幣時間價值及資產／現金產生單位(已計量減值)之特定風險之稅前貼現率計算。

現金產生單位的減值虧損分配用於現金產生單位的資產之間按比例分配。估計變動導致的可收回金額後續增長計入損益，直至回撥減值。

##### (u) 金融資產減值

本集團就貿易及其他應收款項、應收貸款及利息、應收代價以及銀行及現金結餘確認預期信貸虧損的虧損撥備。預期信貸虧損金額於各報告日期更新，以反映自相關金融工具初步確認以來的信貸風險變動。

本集團一貫就貿易應收款項確認全期預期信貸虧損。該等金融資產的預期信貸虧損根據本集團的過往信貸虧損經驗使用撥備矩陣進行估計，並根據債務人的特定因素、整體經濟狀況及對報告日期的當前及預測狀況方向的評估(包括貨幣時間價值(如適用))進行調整。

For all other financial instruments, the Group recognises lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

#### *Significant increase in credit risk*

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;

就所有其他金融工具而言，倘信貸風險自初始確認以來出現大幅增加，本集團確認全期預期信貸虧損。然而，倘金融工具的信貸風險自初始確認以來並無出現大幅增加，則本集團按相等於12個月預期信貸虧損的金額計量該金融工具的虧損撥備。

全期預期信貸虧損指金融工具的預計年期內所有可能違約事件將導致的預期信貸虧損。相反，12個月預期信貸虧損指預計報告日期後12個月內可能發生的金融工具違約事件而導致的全期預期信貸虧損部分。

#### *信貸風險大幅增加*

於評估金融工具的信貸風險自初始確認後是否顯著增加，本集團將於報告日期發生之違約風險與金融工具於初始確認日期金融工具發生之違約風險進行比較。在進行該評估時，本集團會考慮合理且可支持的定量和定性數據，包括無需付出不必要的成本或努力而可得之過往經驗及前瞻性資料。所考慮的前瞻性資料包括從經濟專家報告、金融分析師、政府機構、相關智庫及其他類似組織獲得的本集團債務人經營所在行業的未來前景，以及考慮與本集團核心業務相關的各種外部實際及預測經濟資料來源。

特別是，本集團在評估自初步確認以來信貸風險是否顯著增加時，會考慮以下數據：

- 金融工具的外部(如有)或內部信貸評級的實際或預期顯著惡化；
- 特定金融工具的信貸風險外部市場指標的顯著惡化；

##### *Significant increase in credit risk (Continued)*

- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- significant increases in credit risk on other financial instruments of the same debtor; and
- an actual or expected significant adverse change in the regulatory, economic or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- the financial instrument has a low risk of default;
- the debtor has a strong capacity to meet its contractual cash flow obligations in the near term; and
- adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

The Group considers a financial asset to have low credit risk when the asset has external credit rating of "investment grade" in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of "performing". Performing means that the counterparty has a strong financial position and there is no past due amounts.

##### *信貸風險大幅增加(續)*

- 預計會導致債務人償還債務能力大幅下降的業務、財務或經濟狀況的現有或預測的不利變化；
- 債務人經營業績的實際或預期顯著惡化；
- 同一個債務人的其他金融工具的信貸風險顯著增加；及
- 導致債務人償還債務能力大幅下降的債務人監管、經濟或技術環境的實際或預期的重大不利變化。

不論上述評估結果如何，本集團假定當合約付款逾期超過 30 天，則金融資產之信貸風險乃自初始確認以來已顯著增加，除非本集團擁有合理有據之資料顯示並非如此，則作別論。

儘管存在上述情況，倘金融工具於報告日期被釐定為具有低信貸風險，本集團假設金融工具的信貸風險自初步確認其並無顯著增加。於下列情況下，金融工具被釐定為具有低信貸風險：

- 金融工具違約風險偏低；
- 債務人有強大能力於短期滿足其合約現金流量責任；及
- 較長期的經濟及業務狀況存在不利變動，惟將未必削弱借款人履行其合約現金流量責任的能力。

當資產具有根據國際定義之外部「投資級別」信貸評級或（倘並無外部評級）資產具有內部「履約」級別，則本集團視金融資產具有低信貸風險。履約指交易對手具有強勁財務狀況且並無逾期款項。

##### *Significant increase in credit risk (Continued)*

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

##### *Definition of default*

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable.

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

##### *Credit-impaired financial assets*

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;

本集團定期監察用以識別信貸風險是否顯著增加之準則之效益，並作適當修改，以確保有關準則能夠於款項逾期前識別信貸風險顯著增加。

##### *違約之定義*

本集團視下列各項為就內部信貸風險管理而言之違約事件，原因是過往經驗顯示符合下列任何準則之應收款項一般屬不可收回。

- 當交易對方違反財務契諾時；或
- 內部生成或自外部來源取得之資料顯示債務人不大可能向其債權人(包括本集團)悉數還款(並無考慮本集團持有之任何抵押品)。

不論上文分析如何，本集團認為當金融資產逾期超過90日時，即屬發生違約，除非本集團有合理及有理據的資料證明較滯後的違約標準更為適用則當別論。

##### *信貸減值之金融資產*

倘發生對金融資產的估計未來現金流量有不利影響的一項或多項事件，則該金融資產出現信貸減值。金融資產信貸減值的證據包括以下事項之可觀察數據：

- 發行人或交易對方出現嚴重財政困難；
- 違反合約，如拖欠或逾期事件；

- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

##### *Write-off policy*

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. Any recoveries made are recognised in profit or loss.

##### *Measurement and recognition of ECL*

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

For financial assets, the ECL is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate. For a lease receivable, the cash flows used for determining the ECL is consistent with the cash flows used in measuring the lease receivable in accordance with HKFRS 16.

##### *信貸減值之金融資產(續)*

- 交易對方的貸款人因有關交易對方財務困難的經濟或合約原因向交易對方授出貸款人不會另作考慮的特權；

- 因財務困難而導致該金融資產失去活躍市場。

##### *撤銷政策*

當有資料顯示債務人出現重大財務困難，且日後收回不可實現時，包括債務人已進行清盤或進入破產程序，或（就貿易應收款項而言）當款項已逾期兩年以上（以較早發生者為準）時，本集團會撤銷金融資產。根據本集團收回應收款項的程序，當中經考慮法律意見（如適用），已撤銷的金融資產仍可能受執行活動的影響。收回的任何款項會於損益確認。

##### *預期信貸虧損之計量及確認*

預期信貸虧損的計量為違約可能性、違約虧損率（即出現違約時的虧損幅度）及違約風險的函數。違約可能性及違約虧損率的評估乃按照歷史數據進行，並就上文所述的前瞻性資料作出調整。就金融資產而言，違約風險為該資產於報告日期的賬面總值。

就金融資產而言，預期信貸虧損按根據合約應付本集團的所有合約現金流量與本集團預期將收取按原來實際利率貼現的所有現金流量之間的差額進行估計。就租賃應收款項而言，根據香港財務報告準則第16號，用於釐定預期信貸虧損之現金流量與計量租賃應收款項所用之現金流量一致。

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

#### (v) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

倘本集團已於過往報告期間按相等於全期預期信貸虧損的金額計量金融工具的虧損撥備，惟於本報告日期釐定全期預期信貸虧損條件不再達成，則本集團於本報告日期會按相等於12個月預期信貸虧損的金額計量虧損撥備，惟運用簡化法的資產除外。

本集團於損益中確認所有金融工具的減值收益或虧損，並透過虧損撥備賬項相應調整其賬面值。

#### (v) 撥備及或然負債

倘本集團須就已發生之事件承擔現有法律或推定責任，且履行責任可能涉及經濟利益之流出，並可作出可靠之估計，則須就不確定時間或數額之負債確認撥備。倘貨幣之時間價值重大，則撥備會以預計履行責任之支出現值列示。用於釐定現值的貼現率為稅前利率，該利率反映當時市場對貨幣的時間價值及負債的特定風險評估。因時間的推移而增加的撥備確認為利息開支。

倘不大可能涉及經濟利益之流出，或是無法對有關數額作出可靠之估計，則將責任披露為或然負債，惟流出之可能性極低則除外。須視乎某宗或多宗未來事件是否發生方能確定是否存在可能責任，亦會披露為或然負債，惟流出之可能性極低則除外。

In applying the Group's accounting policies, which are described in note 4, the Directors are required to make judgements (other than those involving estimations) that have a significant impact on the amounts recognised and to make estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### (a) Critical judgements in applying accounting policies

In the process of applying the accounting policies, the Directors have made the following judgements that have the most significant effect on the amounts recognised in the consolidated financial statements (apart from those involving estimations, which are dealt with below).

##### (i) Significant increase in credit risk

As explained in note 4(u), ECL are measured as an allowance equal to 12-month ECL for stage 1 assets, or lifetime ECL for stage 2 or stage 3 assets. An asset moves to stage 2 when its credit risk has increased significantly since initial recognition. HKFRS 9 does not define what constitutes a significant increase in credit risk. In assessing whether the credit risk of an asset has significantly increased the Group takes into account qualitative and quantitative reasonable and supportable forward-looking information.

##### (ii) Deferred tax for investment properties

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the Directors have reviewed the Group's investment property portfolios and concluded that the Group's investment properties are not held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in determining the Group's deferred tax for investment properties, the Directors have adopted the presumption that investment properties measured using the fair value model are recovered through sale. Accordingly, no deferred tax is recognised in respect of the fair value change in such investment property as the Group is not subject to any income taxes on disposal of investment property in Hong Kong because no capital gain tax arising from property sales in Hong Kong.

##### (i) 信貸風險顯著增加

如附註 4(u) 所述，預期信貸虧損就第 1 階段資產按等於 12 個月預期信貸虧損的撥備計量，就第 2 階段或第 3 階段資產按等於全期預期信貸虧損的撥備計量。資產在信貸風險自初始確認後顯著增加時轉入第 2 階段。香港財務報告準則第 9 號並無對信貸風險顯著增加的構成要素作出定義。評估一項資產的信貸風險有否顯著增加時，本集團會考慮合理及有證據支持的定性及定量前瞻性資料。

##### (ii) 投資物業之遞延稅項

為計量使用公平價值模式計量的投資物業所產生的遞延稅項，本公司董事已審閱本集團的投資物業組合，認為本集團投資物業之業務模式的目的並非是隨時間過去消耗投資物業絕大部分的經濟利益，而非透過銷售。因此，於釐定本集團就投資物業之遞延稅項時，本公司董事已採納使用公平價值模式計量之投資物業乃透過銷售收回之假定。因此，由於香港物業出售既無產生資本收益稅項，本集團毋須就出售香港投資物業繳納任何所得稅，故既無就有關投資物業之公平價值變動確認遞延稅項。

#### (b) Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

#### (i) Impairment of loan and interest receivables and consideration receivable

While in estimating ECL on loan and interest receivables and consideration receivable, the Group assesses credit quality on the vendor of Metrotec Limited and each debtor from money lending business based on the borrower's background information, financial position, past settlement experience and other relevant factors to determine the stage of credit quality, probability of default and the loss given default assigned on each debtor together with forward-looking information which are reasonable and supportable available without undue costs or effort. At every reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered.

The vendor of Metrotec Limited and debtors from money lending business are derived from Hong Kong. The provision of ECL on these debtors is sensitive to changes in estimates as the outcome would be vary depending on the selection of input applied. Financial uncertainty triggered by interest rate hike and geo-political situation as well as volatility in financial market, the Group has increased the expected loss rates in the current year as there is higher risk that a prolonged volatility on financial markets could lead to increased credit default rates. The information about the ECL of the Group's loan and interest receivables and consideration receivable are disclosed in note 6(c), note 25 and note 26.

As at 31 December 2024, the carrying amounts of loan and interest receivables are HK\$35,677,000, net of allowance of HK\$33,824,000 (2023: HK\$24,479,000, net of allowance of HK\$62,392,000) and HK\$1,140,000, net of allowance of HK\$1,176,000 (2023: HK\$1,030,000, net of allowance of HK\$3,255,000) respectively.

As at 31 December 2024, the carrying amount of consideration receivable is HK\$3,543,000, net of allowance of HK\$1,912,000 (2023: HK\$5,005,000, net of allowance of HK\$248,000).

#### (b) 估計不明朗因素的主要來源

以下為關於未來的主要假設及於報告期末的估計不明朗因素的其他主要來源，該等假設具有對下一個財政年度內資產及負債賬面值造成重大調整的重大風險。

#### (i) 應收貸款及利息以及應收代價之減值

於估計應收貸款及利息以及應收代價的預期信貸虧損時，本集團根據借款人的背景資料、財務狀況、過往還款經歷及其他相關因素評估 Metrotec Limited 的賣方及借貸業務中各債務人信貸質素，以釐定各債務人信貸質素階段、違約的可能性及違約損失連同毋須付出過多成本或精力即可獲得之合理且可支持的前瞻性資料。於各報告日期，對歷史觀察違約率進行重新評估，並考慮前瞻性資料變動。

Metrotec Limited 的賣方及借貸業務的債務人來自香港。該等債務人的預期信貸虧損撥備對估值的變化很敏感，因為結果會因為輸入值不同而有所變化。加息及地緣政治局勢以及金融市場的波動性加劇了金融不明朗因素，由於金融市場長期波動可能導致信貸違約率上升而致使風險增加，故於本年度本集團之預期虧損率上升。有關本集團之應收貸款及利息以及應收代價的預期信貸虧損之資料披露於附註 6(c)、附註 25 及附註 26。

於二零二四年十二月三十一日，應收貸款及利息的賬面值分別為 35,677,000 港元，扣除撥備 33,824,000 港元（二零二三年：24,479,000 港元，扣除撥備 62,392,000 港元）及 1,140,000 港元，扣除撥備 1,176,000 港元（二零二三年：1,030,000 港元，扣除撥備 3,255,000 港元）。

於二零二四年十二月三十一日，應收代價的賬面值為 3,543,000 港元，扣除撥備 1,912,000 港元（二零二三年：5,005,000 港元，扣除撥備 248,000 港元）。

##### (ii) Impairment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are stated at costs less accumulated depreciation and impairment, if any. In determining whether an asset is impaired, the Group has to exercise judgement and make estimation, particularly in assessing: (1) whether an event has occurred or any indicators that may affect the asset value; (2) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (3) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset (including right-of-use assets), the Group estimates the recoverable amount of the cash-generating unit to which the assets belong. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the net present value used in the impairment test.

The carrying amount of property, plant and equipment and right-of-use assets as at 31 December 2024 were HK\$1,099,000 (2023: HK\$1,601,000) and HK\$4,615,000 (2023: HK\$5,325,000) respectively.

##### (iii) Income taxes

Significant estimates are required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the year in which such determination is made. During the year, income tax of HK\$892,000 (2023: HK\$606,000) was charged to profit or loss based on the estimated result from operations.

The carrying amount of current tax liabilities as at 31 December 2024 was HK\$299,000 (2023: current tax assets of HK\$440,000).

##### (ii) 物業、廠房及設備以及使用權資產之減值

物業、廠房及設備以及使用權資產乃按成本減累計折舊及減值(如有)列賬。於釐定資產是否減值時,本集團須作出判斷及估計,尤其是評估:(1) 是否發生可能影響資產價值的事件或出現任何有關跡象;(2) 資產賬面值是否能以可收回金額作支持,若為使用價值,則為根據持續使用資產估計得出的未來現金流量的淨現值;及(3) 估計可收回金額所用的合適主要假設(包括現金流量預測及合適的貼現率)。倘無法估計個別資產(包括使用權資產)的可收回金額,本集團會估計該資產所屬現金產生單位的可收回金額。更改假設及估計(包括現金流量預測中的貼現率或增長率)可對減值測試中所用淨現值產生重大影響。

於二零二四年十二月三十一日,物業、廠房及設備以及使用權資產的賬面值分別為1,099,000港元(二零二三年:1,601,000港元)及4,615,000港元(二零二三年:5,325,000港元)。

##### (iii) 所得稅

在確定所得稅之撥備時,本集團須作出重大估計。部分交易及計算在日常業務過程中難以明確釐定最終稅務。倘該等事宜之最終稅務結果與最初入賬金額有所不同,該等差額將影響稅務釐定年內之所得稅及遞延稅項撥備。於年內,所得稅892,000港元(二零二三年:606,000港元)按經營所得估計溢利於損益扣除。

於二零二四年十二月三十一日,即期稅項負債賬面值為299,000港元(二零二三年:即期稅項資產440,000港元)。

##### (iv) Fair value of investment properties

The Group appointed an independent professional valuer to assess the fair value of the investment properties. In determining the fair value, the valuer has utilised a method of valuation which involves certain estimates. The Directors have exercised their judgement and are satisfied that the method of valuation and inputs used are reflective of the current market conditions.

Whilst the Group considers valuations of the Group's investment properties are the best estimates, the greater market uncertainty depending on volatility in financial or property markets may progress and evolve, have led to higher degree of uncertainties in respect of the valuations in the current year. Changes to these assumptions, including the potential risk of any market violation, policy, or other unexpected incidents as a result of change in macroeconomic environment, interest rate policy, market expectation from lenders, or mortgage requirements, or other unexpected incidents, would result in changes in the fair values of the Group's investment properties and the corresponding adjustments to the amount of gain or loss reported in the consolidated statement of profit or loss and other comprehensive income.

The carrying amount of investment properties as at 31 December 2024 was HK\$2,200,000 (2023: HK\$2,600,000).

##### (iv) 投資物業的公平價值

本集團已委派一名獨立專業估值師對投資物業的公平價值進行評估。於釐定公平價值時，估值師採用涉及若干估計的估值方法。董事作出其判斷，並相信該估值方法及所用輸入數據能反映當前的市況。

儘管本集團認為本集團投資物業之估值為最佳估計，惟金融或房地產市場的波動可能會導致更大市場不確定性，已導致本年度有關估值高度不確定性。該等假設（包括宏觀經濟環境、利率政策、貸款人的市場預期、抵押要求或其他突發事件導致的任何市場違規、政策或其他突發事件的潛在風險）的變動會導致本集團投資物業的公平值變動及對綜合損益及其他全面收益表所報告收益或虧損金額作出相應調整。

於二零二四年十二月三十一日，投資物業賬面值為 2,200,000 港元（二零二三年：2,600,000 港元）。

### 6. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, price risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

#### (a) Foreign currency risk

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in HK\$. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group monitors its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

#### (b) Price risk

The Group is exposed to equity price risk mainly through its investment in equity securities. The management manages this exposure by maintaining a portfolio of investments with different risk and return profiles. The Group's equity price risk is mainly concentrated on equity securities quoted on the Stock Exchange.

The sensitivity analyses below have been determined based on the exposure to equity price risk at the end of the reporting period.

If equity prices had been 10% higher/lower (2023: 10% higher/lower):

- loss after tax for the year ended 31 December 2024 would decrease/increase by HK\$901,000 (2023: decrease/increase by HK\$979,000). This is mainly due to the changes in fair value of financial assets at FVTPL; and
- other comprehensive income for the year ended 31 December 2024 would increase/decrease by HK\$27,000 (2023: increase/decrease by HK\$27,000) as a result of the changes in fair value of financial assets at FVTOCI.

### 6. 財務風險管理

本集團業務承受多種財務風險：外匯風險、價格風險、信貸風險、流動資金風險及利率風險。本集團的整體風險管理計劃重點關注金融市場的不可預測性，並尋求盡量減低對本集團財務表現的潛在不利影響。

#### (a) 外匯風險

由於本集團大部分業務交易、資產及負債主要以港元計值，故本集團面臨的外匯風險極低。本集團現時並無就外幣交易、資產及負債設立外幣對沖政策。本集團密切監察外匯風險，並將於有需要時考慮對沖重大外匯風險。

#### (b) 價格風險

本集團主要透過其於股本證券投資面臨股本價格風險。管理層透過維持具有不同風險及回報組合的投資組合管理風險。本集團的股本價格風險主要集中於聯交所所報股本證券。

以下敏感度分析乃根據報告期末股權價格風險進行釐定。

倘若股權價格上升／下降 10% (二零二三年：上升／下降 10%)：

- 則截至二零二四年十二月三十一日止年度之除稅後虧損將減少／增加 901,000 港元 (二零二三年：減少／增加 979,000 港元)。此乃主要由於按公平價值計入損益之金融資產公平價值變動；及
- 則由於按公平價值計入其他全面收入之金融資產公平價值變動，截至二零二四年十二月三十一日止年度之其他全面收入將增加／減少 27,000 港元 (二零二三年：增加／減少 27,000 港元)。

### (c) Credit risk

Credit risk is the risk that a counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. The Group is exposed to credit risk from its operating activities (primarily trade receivables, loan and interest receivables) and from its financing activities, including deposits with banks and financial institutions. The Group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks and financial institutions with high credit-rating assigned by international credit-rating agencies, for which the Group considers to have low credit risk.

#### *Trade receivables*

In order to minimise the credit risk, the Directors closely monitor the overall level of credit exposure, and the management is responsible for the determination of credit approvals and monitoring the implementation of the debt collection procedure to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade debt at the end of the reporting period to ensure that adequate loss allowance is made for irrecoverable amounts. The default risk of the industry and region in which customers operate also has an influence on credit risk but to a lesser extent. In this regard, the Directors consider that the Group's credit risk has been significantly reduced.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECL, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

信貸風險為對手方未履行其於金融工具或合約客戶項下之義務，因而導致財務虧損之風險。本集團因其經營活動（主要為貿易應收款項、應收貸款及利息）及融資活動（包括銀行及金融機構之存款）面臨信貸風險。由於對手方為獲國際信用評級機構評定信用評級較高之銀行及金融機構，本集團認為其信貸風險較低，故本集團因現金及現金等價物而面臨之信貸風險有限。

#### *貿易應收款項*

為盡量降低信貸風險，董事密切監控信貸風險的整體水平，管理層負責確定信貸批准並監控收債程序的執行情況，以確保採取後續行動收回逾期債務。此外，本集團於報告期末檢討各個別交易債務的可收回金額，以確保對不可收回的金額計提足夠的虧損撥備。客戶經營所在行業及地區之違約風險亦對信貸風險造成影響，對出租人而言亦是如此。就此而言，本公司董事認為，本集團的信貸風險已大為降低。

本集團為貿易應收款項計量虧損撥備，其數額等於使用撥備矩陣計算之全期預期信貸虧損。由於本集團之歷史信貸虧損經驗顯示，不同客戶分部之虧損模式並無顯著差異，故基於逾期狀態作出之虧損撥備並無進一步於本集團不同客戶群之間作出區分。

##### Credit risk management

In respect of loan and interest receivables arising from the money lending business, the management manages and analyses the credit risk for each of their new and existing customers before standard payment terms and conditions are offered. The management assesses the credit quality of each customer based on the customer's background information, financial position, past settlement experience and other relevant factors. The Group also reviews from time to time the financial conditions of the customers. In this regard, the Directors consider that the Group's credit risk has been significantly reduced.

The Group has implemented strict controls over collateral associated with defaulted loans to mitigate credit risk. This include review of legal enforceability of the collateral to ensure recovery rights are upheld and legal actions to be taken if the loans are considered in default.

##### *Measurement of ECL*

The Group measures loss allowance under HKFRS 9 ECL model. The measure of ECL is a function of the probability of default, loss given default (i.e., the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data, collateral values, credit rating of customers and adjusted by forward-looking information.

Generally, the ECL is estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the effective interest rate determined at initial recognition.

Interest income is calculated based on the gross carrying amount of the financial asset unless the financial assets is credit impaired, in which case interest income is calculated based on amortised cost of the financial asset.

The key inputs used for measuring ECL are:

- Probability of default (PD);
- Loss given default (LGD); and
- Exposure at default (EAD)

These figures are generally derived from internally developed statistical models and other historical data and they are adjusted to reflect forward-looking information.

Elements of the ECL models that are considered accounting judgements and estimates include:

- The Group's estimation of probabilities of default to individual customers;
- The Group's criteria for assessing if there has been a significant increase in credit risk and so allowances for financial assets should be measured on a lifetime ECL basis and the qualitative assessment;

- Development of ECL models, including the various formulas and the choice of inputs over determination of the period over which the entity is exposed to credit risk based on the behavioural life of the credit exposures, loss given default and collateral recovery of the credit exposures; and
- Determination of associations between macroeconomic scenarios and, economic inputs, such as delinquency ratios and collateral values, and the effect on probabilities of default, exposures at default and losses given default.

It is the Group's policy to regularly review its model in the context of actual loss experience and adjust when necessary. The assumptions underlying the ECL calculation are monitored and reviewed on a half-year basis. There have been no significant changes in estimation techniques or significant assumptions made during the reporting period.

The Group categorises the credit quality of its loan and interest receivables according to 3 different stages under the ECL model:

- Stage 1: financial assets without significant increase in credit risk since initial recognition where loss allowance is calculated based on 12-month ECL
- Stage 2: financial assets with significant increase in credit risk since initial recognition where loss allowance is calculated based on lifetime ECL
- Stage 3: credit impaired assets where loss allowance is calculated based on lifetime ECL

The Group has taken into account the probability of default and loss given default with reference to the historical delinquency ratio of loan, collateral values, credit rating of customers and current and forward-looking information on macroeconomic factors.

The assessment of significant increase in credit risk is performed periodically for all loans and interest receivables held by the Group. For consideration receivable that is not credit-impaired without significant increase in credit risk since initial recognition ("Stage 1"), ECL is measured at an amount equal to the portion of lifetime ECL that results from default events possible within the next 12 months. If a significant increase in credit risk since initial recognition is identified ("Stage 2") but not yet deemed to be credit-impaired, ECL is measured based on lifetime ECL. If credit impaired is identified ("Stage 3"), ECL is measured based on lifetime ECL.

##### *Concentration of credit risk*

At 31 December 2024, the Group had certain concentration of credit risk as 42.65% (2023: 13.58%) and 81.14% (2023: 49.29%) of the total trade receivables, net of ECL allowance was due from the largest trade customer and five largest trade customers respectively.

At 31 December 2024, the Group had certain concentration of credit risk as 14.35% (2023: 20.99%) and 49.21% (2023: 59.81%) of the total loan receivables, net of ECL allowance, was due from the largest borrower and five largest borrowers respectively.

##### *Other financial assets at amortised cost*

All of the Group's other financial assets at amortised cost are considered to have low credit risk, and the loss allowance recognised during the period was therefore limited to 12-month expected losses. They are considered to be low credit risk when they have a low of default and the issuer has a strong capacity to meet its contractual cash flow obligations in the near term.

Financial assets at amortised cost include time deposit at bank with original maturity over three months, due from an associate, other receivables and cash and cash equivalents.

#### (d) Liquidity risk

Individual operating entities within the Group are responsible for their own cash management, including the participation in supplier finance arrangements with banks and the raising of loans to cover expected cash demands, subject to approval by the Directors of the Company when the borrowing exceed certain predetermined level of authority.

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term.

#### (e) Interest rate risk

Interest rate risk is the risk that the value of a financial instrument or the interest income of a portfolio will fluctuate due to changes in market interest rates. The Group's major interest-bearing assets and liabilities at the end of the reporting period are bank deposits, interest-bearing loan receivables and lease liabilities under finance lease arrangement. Interests on bank deposits are principally based on deposits rates offered by banks in Hong Kong. Interest-bearing loan receivables and lease liabilities under finance lease arrangement are charged at fixed rates.

The Group manages its interest rate exposure by matching the interest rate profile of its assets and liabilities. The Board is responsible for ensuring the policy is appropriate and sufficient to monitor the interest rate exposure of the Group, by regularly monitoring the benchmark interest rates of products offered against prevailing market conditions. All of the Group's loan receivables and lease liabilities carried fixed interest rates. The Group prices these loan receivables strategically to reflect market fluctuations and achieve a reasonable interest rate spread.

Accordingly, no sensitivity analysis is presented for interest rate risk.

None of these segments meets any of the quantitative thresholds for determining reportable segments. The information of these other operating segments is included in the "Others" column.

#### (a) Pension – defined contribution plan

The Group contributes to defined contribution retirement plans which are available for eligible employees in the PRC and Hong Kong.

Pursuant to the relevant laws and regulations in the PRC, the Group has joined defined contribution retirement schemes for the employees arranged by local government labour and security authorities (the "PRC Retirement Schemes"). The Group makes contributions to the PRC Retirement Schemes at the applicable rates based on the amounts stipulated by the local government organisations. Upon retirement, the local government labour and security authorities are responsible for the payment of the retirement benefits to the retired employees.

The Group operates a MPF Scheme under the Mandatory Provident Fund Schemes Ordinance (Chapter 485 of the laws of Hong Kong) for employees employed under the jurisdiction of Hong Kong Employment Ordinance (Chapter 57 of the laws of Hong Kong). The MPF Scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF Scheme, the employer and the employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000.

During the years ended 31 December 2024 and 2023, the Group had no forfeited contributions under the PRC Retirement Scheme and the MPF Scheme and which may be used by the Group to reduce the existing level of contributions. There were also no forfeited contributions available at 31 December 2024 and 2023 under the PRC Retirement Scheme and MPF Scheme which may be used by the Group to reduce the contribution payable in future years.

The Group seeks to maintain strict control over its outstanding loan receivables so as to minimise credit risk. The granting of loans is subject to approval by the credit committee, whilst overdue balances are reviewed regularly for recoverability.

As at 31 December 2024, the loan receivables were charging on interest rates ranging from 8% to 35.5% per annum (2023: 8% to 21.6% per annum) and were repayable with fixed terms agreed with the contracting parties generally ranging from 3 months to 25 months (2023: 3 months to 25 months). The Group held collateral such as jewelry and properties or other credit enhancement i.e. guarantees over the loan receivables balance of HK\$11,167,000 (net of provision for impairment loss of HK\$1,833,000) (2023: HK\$2,725,000 (net of provision for impairment loss of HK\$4,256,000)), and loan receivables balance of HK\$24,510,000 (net of provision for impairment loss of HK\$31,991,000) were unsecured (2023: HK\$21,754,000 (net of provision for impairment loss of HK\$58,136,000)).

Included in loan receivables is a loan with principal amount of HK\$2,800,000 (2023: HK\$2,800,000) lent to a related company. The director of the related company's ultimate holding company is also the Company's Director. It bears interest of 8% per annum with maturity on 22 December 2024. The amount is guaranteed by the ultimate holding company of the borrower. On 23 December 2024, a supplemental agreement was entered with the related company and the maturity date of the loan to the related company was extended to 22 December 2026. It bears the same interest of 8% per annum and continues to be guaranteed by the ultimate holding company of the borrower. Details of the extension of the loan is set out in the Company's announcement dated 23 December 2024.

After considering the historical payment pattern of this related party, the management of the Group considered the credit risk has been improved and expected the credit risk after contract modification would not be deteriorated, so that the loan is transferred from stage 2 to stage 1.

Such modification of a contract between the Group and a related party may result in a change to the contractual cash flows without resulting in the derecognition of the financial assets as the modification solely on the maturity date provided that the reminding terms remain unchanged. The risk of default of such assets after modification is assessed at the reporting date and compared with the risk under the original terms at initial recognition, when the modification is not substantial and so does not result in derecognition of the original asset and the book value of the financial asset is recalculated and the related gain or loss is included in current profit and loss.

The Group manages its capital to ensure that the entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. No changes were made in the objectives, policies or processes for managing capital during the years ended 31 December 2024 and 2023.

The Directors review the capital structure on a regular basis. As part of this review, the Directors consider the cost of capital and the risks associated with each class of capital. The Group seeks to balance its overall capital structure through new share issues as well as the issue of new debt or the redemption of existing debt.

The Group monitors capital on the basis of the debt-to-adjusted capital ratio. This ratio is calculated as net debt divided by adjusted capital. Total debt comprises lease liabilities. Adjusted capital comprises all components of equity (i.e. share capital, share premium, accumulated losses and other reserves). As at 31 December 2024, the Group's net debt-to-equity ratio was not applicable because the Group had HK\$10,857,000 (2023: HK\$9,214,000) cash and cash equivalents which can be sufficient to repay all the debts of the Group.

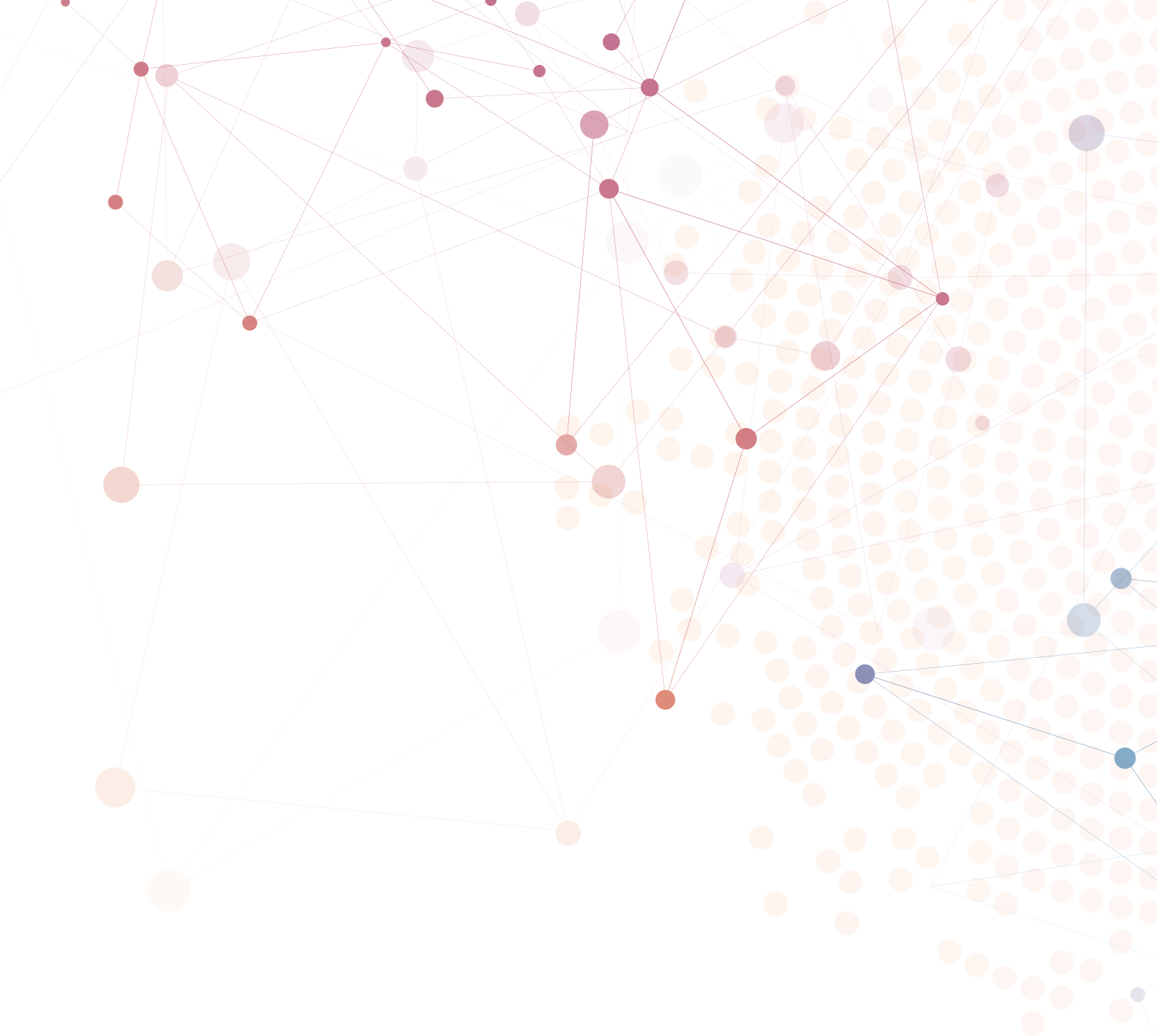
